EDUCATION

Throughout fiscal year 2017, the Chapter offered several **training opportunities to our members**. Our professional development program included 8 free audio conferences, free CGFM training, and presentations on topics such as cybersecurity, trends in financial management, data analytics, and many others. Also, the Chapter conducted the two-day 16th Annual AGA DC Federal Financial Management Training event. Over 200 professionals attended this signature event which provided 16 hours of continuing professional education.

CERTIFICATION

The CGFM Committee, continued to promote the value of certification, leading training efforts including a six-day course provided to 30 professionals in March and May 2017, as well as winning the 2017 Chapter CGFM Award in adding **15 new recipients of the CGFM**. The certification continues to be the premiere Federal financial management indicator of professional commitment to education and expertise.

AWARDS

In March 2017, the Chapter hosted nearly 180 members at our annual Awards Gala, following the Federal Financial Management Event. The DC Chapter is nationally recognized as a **Platinum level Chapter**, our members were recognized for their service and achievements in promoting the mission of AGA. In addition to the Chapter CGFM Award received by Robbie Jordon and Wendy Allen, R. Scott Bell received the 2017 Educator Award and Christine Bang and Sakina Washington received the Chapter Community Service Award. The DC Chapter received a Certificate of Excellence for an award winning Citizen Centric Report for 2016.



MEMBER VALUE

The Chapter membership as of September 28, 2017 was 1,887, including over 70 new members, and realizing a continued focus on increasing member value throughout the fiscal year. In 2017 we **offered over 3,500 valuable CPE hours** across our membership through luncheons, free audio conference, and training events.

INCREASED LEADERSHIP PARTICIPATION

Throughout the year, there was a renewed focus on increasing the participation in the Chapter Leadership. After a heavy recruiting blitz, many of **the committees welcome new members** bringing fresh ideas and increased energy to the programs the Chapter promotes.



COLLABORATION AND SERVICE

Favorites like the Lunar New Year and the Cherry Blossom Tour are among the social events held during the year. Some events included participation from other Capital region chapters and the National office, including the September 2017 **Tri-Chapter picnic**. The Meetings Committee organized 8 CPE luncheons averaging peak capacity of over 200 professionals, and with such strong attendance the DC Chapter will continue to utilize a larger venue permanently for 2018.

Members volunteered to support nonprofit organizations such as the Junior Achievement's JA Finance Park® program, DC Child and Family Services Agency, and Toys for Tots.

THOUGHT LEADERSHIP

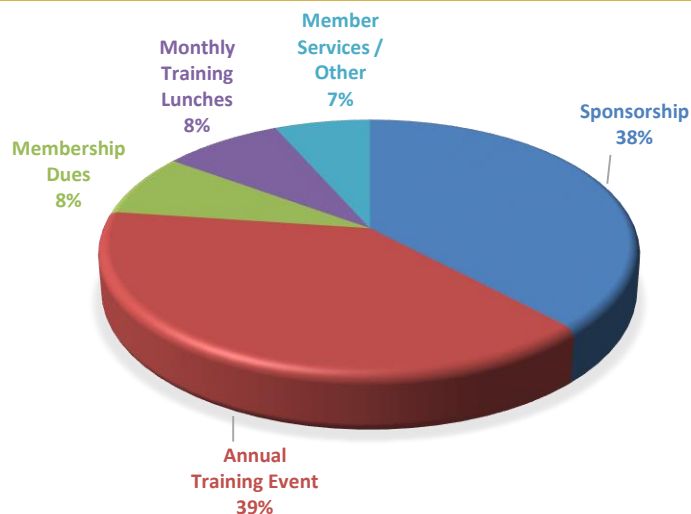

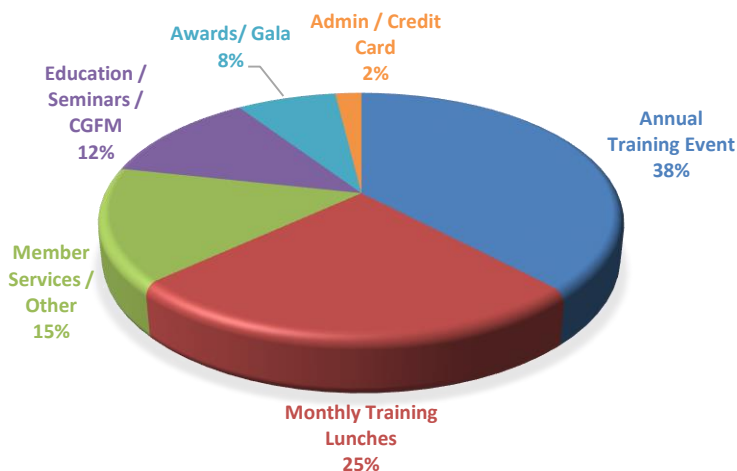

RAISING PUBLIC AWARENESS OF GOVERNMENT ACCOUNTABILITY, TRANSPARENCY AND PERFORMANCE

The DC Chapter promotes AGA's performance and accountability programs (CEAR and CCR) to the chapter members and the community. The challenges faced are:

- Encouraging chapter members to implement the relevant program within their agency/organization and actively seek transparent reporting opportunities with the public;
- Encouraging chapter members to participate in the programs as reviewers; and,
- Promoting public awareness and confidence in the integrity, competence and professionalism of government accountability professionals.

CHALLENGES & MOVING FORWARD

BUILD SUPPORT FOR THE CERTIFIED GOVERNMENT FINANCIAL MANAGER (CGFM) DESIGNATION

The Chapter continues to promote the CGFM Program through various education, speaking, and training efforts. The challenge remains in expanding awareness of this certification outside the beltway and beyond AGA, advancing official recognition of the CGFM certification within government agencies.



EXPANDING EDUCATIONAL SUPPORT FOR MEMBERS AND CGFMS

One of the ways of attracting and retaining highly competent professionals is providing ongoing training and education. In today's environment of high-end technology and shrinking budgets, the challenge is to make innovative and cost-efficient use of electronic media to provide quality education and training.

ATTRACTING YOUNG PROFESSIONALS

A recent study in the Higher Education Journal listed the Federal Government as third in the long-term accounting career choice amongst accounting students, with many young accountants unable to recognize the appeal of Federal service. Our goal is to promote the AGA and CGFM, while making the government an attractive and viable career choice for younger professionals.

CONTINUED CAPITAL REGION CROSS COLLABORATION

As part of the greater capital region, the chapter will seek to broaden education, service, networking, and thought leadership through integration with Regional Vice-President and various local chapter leaders. We recognize that greater collaboration offers increased value to our members, and greater outreach to the Federal financial management community.

LEADERSHIP SUCCESSION

The Chapter is looking to expand the level of high-quality events and activities being offered to members and, as with any organization, could lose superior leaders in due course. The Chapter has proactively recruited new members to serve in an assistant capacity to develop a deeper understanding of specific leadership roles and a broader understanding of the chapter functions. This experience will enable these members to take leadership roles in the future to position the Chapter for continued success. In addition, the Chapter leadership structure provides for a past president (Wendy Morton-Huddleston), president (Salim Mawani), and president-elect (Jorge Asef-Sargent) each with broad perspectives on the goals and operations of the organization.
