Hello Nashville AGA Members! Welcome to our monthly newsletter for March. We have a lot of interesting news and features in this month's issue, and I want to highlight a few items as we go into an important time of year for AGA and our chapter.

Citizen-Centric Reporting (CCR) By Gerry Boaz, CGFM, CPA, CGMA

No, I am not talking about Creedence Clearwater Revival (CCR). Instead, it's another kind of CCR about which we need to inform our colleagues and especially our fellow citizens. Most, if not all, of us do not have time to read a government's annual financial report or a comprehensive annual financial report (CAFR), which could be as voluminous as 250 pages with no plot, irony, tragedy, or comedy. The only tragedy is having to read through the complex maze of the basic financial statements, management's discussion and analysis, notes to the financial statements, required supplementary information, and supplementary information. According to a 2010 AGA survey, the current state of governmental reporting has resulted in dissatisfied citizens, a distrust in government, and technical reporting the citizens cannot understand. Citizens believe they are entitled to transparent financial information, and governments have an obligation to provide the information. Fortunately, AGA has the solution with a CCR because it is short, understandable, easy to read, and informative.

According to AGA's website,

"Governments at all levels — federal, state, local and tribal — seek to be transparent with their spending, yet many transparency websites only provide access to complex financial reports that require an accounting degree to understand! Some government sites also provide query capabilities and graphical depiction of data, but not a comprehensive look into their mission, spending, performance and outlook."

I remember back in 2009 when Congress passed and the President signed the Accountability Recovery and Reinvestment Act (ARRA) into law. As a direct result, the TN Department of Finance and Administration (F&A), as well as other state Controller offices, developed transparency websites since they were the primary recipients of the ARRA federal financial assistance. This was a good baby step but was more of a data dump than a presentation in a form that provided decision-useful information.

AGA's CCR initiative is intended to simplify communication between governments and its citizens. With accurate government financial information in a simple and understandable format, citizens can assess how government is spending their taxpayer dollars and what the outcomes were. AGA made preparing a CCR easy for preparer governments by describing what content should be presented on each CCR page. In addition, AGA posted a standard template format on its website to make it easier for preparers to complete in a timely manner.

So, what content goes on each page of a CCR? Luckily, AGA has numerous examples of governmental and AGA Chapter CCRs on its website to give preparers good, creative ideas.

The following provides specific guidance to help the preparer get started:

In conclusion, is a CCR worth it? Clearly, the answer is YES. The government and citizens both benefit from a simpler, more understandable CCR communication. A more-informed citizenry is better able to assess that limited resources have to be prioritized, and the prioritized spending has specific outcomes. If we view preparation of a CCR from the perspective of what we government employees would want to know if we did not have access to the internal information, what should we present on the four pages? More transparent information communicated to citizens improves their decisions-making capabilities. CCRs can help citizens become more active and better-informed voters.

As most of our members are aware, AGA has embarked on some exciting new governance changes in the last year. The goal of the changes is to reshape and modernize how our organization works at the highest levels. This includes addressing chapter representation and re-working the regional structure we have operated under for many years. Specific changes include restructuring the National Board of Directors and creating the National Council of Chapters (NCC), which will have one representative from each AGA chapter. Penny is an Assistant Director with Local Government Audit in the Tennessee Comptroller's Office, and she has served in numerous leadership roles with AGA, including Chapter President and Southeast Region Vice President. We sat down for a conversation with Penny to discuss AGA and this exciting new role.

Question: Many of our members feel like we know you really well either from working with you in the Comptroller's Office or from your time as Chapter President. But what is something new, interesting, or exciting going on in the life and career of Penny Austin?
