Speaker: Dr. Sridhar (Sri) Ramamoorti



Dr. Sridhar Ramamoorti, ACA, CPA/CITP/CFF/CGMA, CIA, CFE, CFSA, CGAP, CGFM, CGMA, CRMA, CRP, MAFF, is currently an Associate Professor in the School of Accountancy and Director-Board Culture and Behavioral Dynamics, Center for Corporate Governance at Kennesaw State University, in Kennesaw, Georgia. He specializes in corporate governance, risk management, external and internal auditing, internal controls, international financial reporting standards (IFRS), and forensic accounting. A prolific contributor to the literature in governance, risk, and compliance, Dr. Ramamoorti is co-author of over 35 articles in respected academic and practitioner-oriented journals, as well as 12 books and monographs.From 1998-2010, Dr. Ramamoorti served on the editorial board of AGA's Journal of Government Financial Management, earned the CGFM designation in 2006, and continues to be an Atlanta-chapter member. He won the AGA National President's award twice: in 2004 for journal editorial service, and in 2006, for chairing the Academy for Government Accountability. Her recent research has focused on cutback budgeting, tax reform, intergovernmental fiscal relations as well as the legislative budget processes and decision-making. Recent publications include a review of State Tax Reform efforts around the country, Georgia's effort to implement program based budgeting published in the Journal of Public Budgeting and Finance and legislative influences on performance based budgeting reform in Public Administration Review.
