Assignments may include system administrator responsibilities for the Budget and Financial Management System.

- ◆ **Experience**—have at least two years of professional-level experience in government financial management.

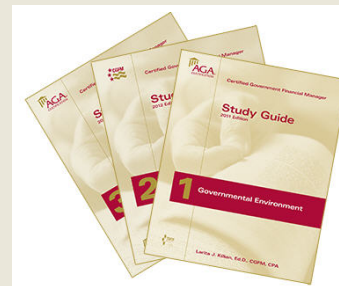

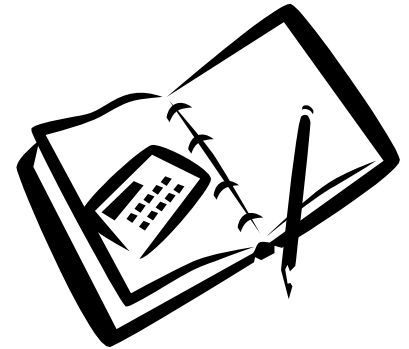
