# February Speaker — Special Agent Michael P. Klier



Special Agent Michael P. Klier

Michael P. Klier has been assigned to the Nashville Resident Agency of the U.S. Department of Veterans Affairs, Office of Inspector General (VA OIG) since October 2010. In this capacity, SA Klier has investigated fraud against the VA, including Service Disabled Veteran Small Business fraud, benefits fraud, drug diversion and a range of other criminal and civil matters.

Prior to joining the VA OIG, SA Klier was a Special Agent with the Naval Criminal Investigative Service, where he was the fraud agent for Patuxent River Naval Base. SA Klier started his federal law enforcement career with the US Secret Service in Atlanta, Georgia where he investigated international fraud and mortgage fraud. He was also assigned to the Germany Office where he handled financial fraud, including bank and credit card fraud, throughout Europe. SA Klier has received numerous awards throughout his law enforcement career. He has also served as an Intelligence Specialist with the Department of the Army and was a Professional Staffer for the Small Business Committee for the U.S. House of

SA Klier received an MA from Indiana University, received a Fulbright Scholarship to study in Germany and received undergraduate degrees from Canisius College in Buffalo, NY. SA Klier is also a graduate of the Military Intelligence Officer Basic Course in Ft. Huachuca, AZ, which he completed as a civilian.

Way back in June 1978, the Nashville Area AGA Chapter was started under the leadership of Frank Greathouse, who at the time was the Director of the Division of State Audit in the Office of the Tennessee Comptroller of the Treasury. The Association of Government Accountants began as an organization of federal employees, and when they decided to include state and local government employees, Mr. Greathouse was convinced that Tennessee needed to get involved. I was one of several individuals from the Department of Audit (which at that time included State Audit, County Audit, and Municipal Audit) who decided to become charter members of the new chapter, including my now husband of almost 38 years, Herman G. "Jack" Henry. We also had some individuals from other state departments and agencies who joined. I don't recall whether we had any metropolitan government members in the initial group, but we did have at least one member from a national CPA firm. Mr. Greathouse was selected as the chapter's first President, and Dr. Mortimer Dittenhofer, AGA Executive Vice President, came down from the national office to present our charter, which lists 134 charter

members "who pledge their efforts to further the objectives of the Association and the ideals of sound Governmental financial management." I don't know if any of us realized how momentous that occasion was at the time.

The Nashville Chapter will soon be celebrating its 40<sup>th</sup> anniversary, and as the chapter has evolved over these many years, the Department of Audit has continued to be very much involved in chapter activities with numerous members of management and staff serving as officers, directors, committee leaders, and committee members. Many of our chapter members have also served at the regional and national level, which is a great source of pride for our chapter. In fact, the current National President is our own Jim Arnette, Director of the Division of Local Government Audit in the Comptroller's Office. The Nashville Chapter has grown significantly from our humble beginnings to be a nationally recognized chapter with a current membership of more than 340. There is even a national award named after our first president, the Frank Greathouse Distinguished Leadership Award, and a national award named after a former Tennessee Comptroller, the William R. Snodgrass Distinguished Leadership Award. Some of the chapter's more significant contributions through the years have been the many educational opportunities provided to our members and others and the numerous and varied community service projects in which we have participated. Our chapter has received national awards for both the educational and community service activities on multiple occasions. We have also been privileged to host national and regional professional development training events.

Through the years, I had participated in various capacities including Newsletter Editor, Awards Committee member, Membership Committee member, and for the most part a regular attendee at the monthly chapter meetings, but I had never really experienced the "behind-the-scenes" workings of our chapter. However, in early 2009, Scarlet Sneed, acting on behalf of the Nominations Committee, asked me if I would accept the nomination for Chapter Secretary for the 2009 - 2010 chapter year. Although I wasn't quite sure exactly what I was getting myself into, I accepted without hesitation. My service as Chapter Secretary was very enlightening and gave me a much greater appreciation for what is involved in running a chapter of this size. The monthly Chapter Executive Committee meetings highlight the hard work put forth by the officers, directors, and numerous committees, which make our chapter the outstanding chapter that it is. I had no idea!!



When Melvin Jones, Jr. called me in early 2010, on behalf of the Nominations Committee, and asked me if I would accept the nomination for President-Elect for the 2010 - 2011 chapter year, I was overwhelmed and told him that I would have to give that some thought. We have enjoyed such a rich history of chapter leadership through the years, and I wanted to be able to continue that tradition. After giving it a great deal of thought,
