What are the initial requirements?

To earn the CGFM, individuals must apply for the CGFM program and meet the following requirements:

Ethics — read and agree to abide by AGA's Code of Ethics

Education — have a bachelor's degree from an accredited college or university

Examinations — pass three comprehensive CGFM examinations

Experience — have at least two years of professional-level experience in government financial management

What is CGFM?

Certified Government Financial Manager® (CGFM®) is a professional certification awarded by AGA, demonstrating competency in governmental accounting, auditing, financial reporting, internal controls and budgeting at the federal, state and local levels.

Have you heard of the CGFM certification? Are you interested in enhancing and showcasing your knowledge in government finance? The Certified Government Financial Manager (CGFM) is a professional certification awarded by AGA.

What do I have to do?

Read and agree to abide by the AGA's Code of Ethics.

Hold a bachelor's degree from an accredited college or university.

Pass three comprehensive CGFM exams.

Have at least two years of professional level experience in government finance management.

What are the benefits?

Increase and showcase your knowledge.

Distinguish yourself.

Enhance your marketability through all levels of government.

How can our South Dakota AGA chapter help?

Reimbursement for 50% of the examination fees (up to \$187.50).

CGFM study materials are available for members to use.

Connect with other individuals who are currently pursuing their CGFM certification.

Connect with individuals who already hold the CGFM certification.

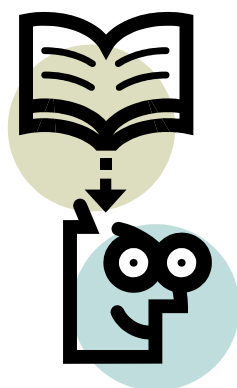
