APRIL Luncheon Recaps



Speaker: Cathy Holland-Smith

Our March luncheon honored all CGFM graduates with free lunch in honor of their achievement this month. We started the meeting with a CCR presentation by **Michael Pearson**, our Accountability chair who encourages everyone to submit a CCR to provide transparency to the public. Michael also shared that the Transportation Dept's CCR was the best that AGA National had ever seen. Congratulations to them!!

Our March luncheon hosted guest speaker, **Cathy Holland-Smith** who serves as the Division Manager for the Budget & Policy Analysis division for Legislative Services Office. She gave us a broad overview and comparison of the General Fund for FY15 and FY16's current picture.

Cathy emphasized that we heavily rely on forecasting when determining our future revenues and how much

money we can spend. She gave us an informative breakdown of each section of the General Fund budget & explained what changes had occurred between both fiscal years.

Cathy also refreshed us that appropriations are not ongoing and those requesting funds should get a more steady revenue stream like a transfer from a tax source. She pointed out the ongoing concern that government was expanding rapidly again, since the economy was recovering from the recession. She shared with us appropriation numbers were very similar to FY2009 & reassured that things were still conservatively budgeted. Cathy ended the presentation by answering questions asked by AGA Members about various concerns with the current legislature session & budget. Her feedback was very insightful quest and educational!

Why did you join AGA? I joined AGA because the knowledge and networking you gain from being a


member is priceless. In addition, I see it as a great way for me to give back to our community by encouraging younger generations the importance of continuing their education in order to fully develop as a business professional.

Minutes from previous meeting: Carol Bearce moved and Matt Orem seconded the motion to approve the previous meeting's minutes with minor typo corrections. The motion passed.

Treasurer's Report: Chris Stratton moved and Katie Curran seconded the motion to approve the Treasurer's Report. The motion passed. Minor expenses were discussed.

President's Update: Judy Shock attended the National Leadership Training (NLT) in Washington DC and reported that it was excellent. At the NLT, Chris Warner, Adventurer and Leadership Expert, gave a great presentation on teambuilding. Other attendees gave compliments to Idaho Transportation Department's CCR. Chris Stratton and one other Chapter leader will attend the SLM in May. National would prefer that attendees be members who have not previously attended. Feb 21, 2015 Luncheon Minutes AGA



Meeting called to order at 12:00 noon.

Announcements: The Greenbelt Cleanup Community Service signup sheet is being passed around.

Speakers: Representative Maxine Bell and Senator Dean Cameron

Topic: Legislative Processes and Issues

Representative Bell explained that in the budget setting processes the phrase 'beyond there may be dragons' is very appropriate. JFAC works with the best information available and then flies by the seat of their pants in setting the budgets. Revenues exceeded projections by \$20 million in December and by \$1 million in January. Setting the budgets is a balancing act but schools and people must come first. Idaho is still not back to where we should be in those areas. There is low unemployment but still lots of food stamp recipients. Corporate taxes were stable over the winter. Sales tax receipts were wobbly. JFAC is fiscally conservative but not mean. JFAC is consistently hearing that agencies are behind on infrastructure maintenance and good talent has been lost in the last few years.

Senator Cameron thanked the luncheon attendees for all of our work. The economy is coming back but is sluggish. Sales tax and personal income taxes are down. Health insurance increases for State of Idaho employees will be covered. A 3% increase in employee compensation (CEC) will be in agency appropriation bills for FY16. Budget setting starts on Tuesday, February 24. More students are enrolling in K through 12 and will need to be funded. Agencies may not get all replacement items that are requested.

Streamlined income tax reform is being considered and may include a flat tax. Removing sales tax from groceries was previously recommended.

Highways need attention. Bridges are designed to last 50 years and more are that old. Unfortunately, many may have to last 150 years.

Most budget complications are on the revenue side. Education must be funded, but there are so many tax breaks that all the pieces of the funding do not fit together. Phasing in of some policies could create possible collisions in the future. The discussion of funding highways from the general fund could result in a \$20,000,000 hit to the general fund.
