In the Spotlight

Scott T. Hall

Georgetown-Scott County Revenue Commission, Executive Director

How did you choose government financial management as your career? After spending most of my working adult life in the private sector (including District Management at Jackson Hewitt Tax Service), I saw a job posting for a Supervisor position at the Louisville Metro Revenue Commission. I applied, interviewed and I got the job. That was 14 years ago, and I can honestly say I have never regretted it.

What advice would you give a recent graduate joining the field? Two things: A) Find a Mentor. While Degrees and Certifications do an excellent job of building a solid foundation, a good Mentor will guide you through how things work in the “real world.” B) Hone the soft skill of building positive relationships. The key to long term success in nearly every aspect of life is building positive relationships.

What accomplishments are you most proud of in your career? A) Successfully completing the Comparative Tax Policy and Administration studies in Executive Education at Harvard University’s John F. Kennedy School of Government. It was the experience of a lifetime. B) Successful completion of my 3-year U.S. Department of Treasury appointment to the IRS Taxpayer Advocacy Panel. It was a volunteer experience like no other. C) After nearly 6 years in my current role (and with the help of an Outstanding Team), we have accomplished many things to be proud of as we continue to transform GSCRC into an innovative tax agency. In FYE 6.30.2021 we achieved the highest total Tax Revenue Collections in the 17-year history of the GSCRC. As we head into the last month of FYE 6.30.2022, we are currently on track to exceed last year’s collections record.

Do you have a mentor and how has this person helped you? I have had several mentors over the years, and they have all given me valuable advice. One of my favorite pieces of advice goes something like this...”If you are not willing to take the chance that you might look stupid, nothing truly great is ever going to happen to you in your life.” I have found that to be true. More than once.

How did you get involved in AGA? My friend & colleague, Kim Krugel, CPA–Tax Administrator, Boone County Fiscal Court, invited me to attend as her Guest several years ago. I have been AGA ever since.
