

## **Agency Information**

The Department of Health and Human Services (DHHS) provides supportive, preventive, protective, public health and intervention services that protect the public health and assist our customers in meeting their needs; and that assist families in providing for the developmental, health and safety needs of their children. DHHS strives to provide these programs and services while respecting the rights and preferences of individuals and families. DHHS programs are funded by both the Federal and State government and as such, must comply with Federal and State regulations and program requirements.

The Division of Audit is responsible for providing audit oversight services to all DHHS Offices. These services include identification of potential risks, implementation of internal controls to mitigate risk and auditing of programs and services to test for compliance. We currently have 3 vacancies in our Augusta office. These positions may require occasional statewide travel.

## **Job Duties**

As an Auditor I you will perform professional audit work under the direction of senior auditors of MaineCare (formerly Medicaid) Providers and Community Agencies who receive state and federal pass thru funds from the Department of Health and Human Services. You will be called upon to assist/complete financial and compliance audits of annually filed cost reports regarding usage of public funds for conformance to established laws, rules, regulations and standards. To

successfully perform these duties, you must understand GAAP, GAAS and be skilled with computers, particularly spreadsheet applications. You must be detail oriented and have a high degree of self-motivation. As an Auditor I you will contribute to the Departments mission and goals by helping to ensure public assistance funds are utilized for the purposes enacted in legislation. You will have opportunities to grow personally and professionally as you acquire knowledge of Medicare, Medicaid, the federal single audit act (A-133) and the state single audit act (MAAP) and applicable laws and regulations and become proficient in the review and auditing of financial statements and cost reports prepared by non- profit and proprietary corporations.

## Requirements

To qualify you must have a Bachelors Degree\* in Accounting, Business Administration, or related field -OR- a four (4) year combination of education, training, and/or experience at the professional level in auditing and accounting. The background of well-qualified candidates should demonstrate knowledge of GAAP and/or GAAS and proficiency with standard desktop applications, particularly word processing and spreadsheet applications.

\*Only post-secondary degrees from a College or University whose accreditation has been granted from a nationally recognized accreditation agency recognized by the U.S. Secretary of Education will satisfy educational requirements. - **Examinations** pass three comprehensive CGFM Examinations.
- **Experience** have at least two years of professional-level experience in government financial management.
