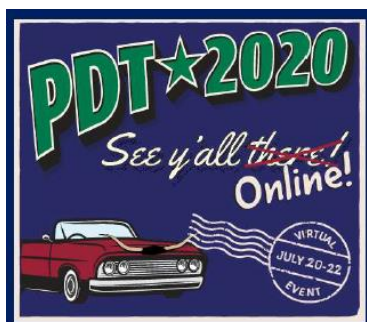

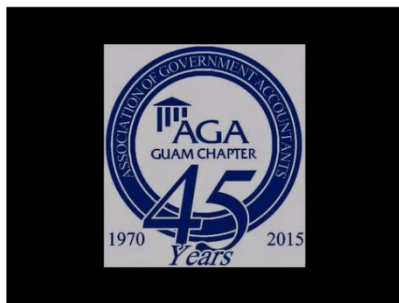

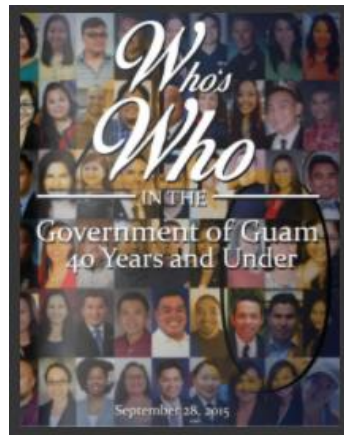

Pearson Vue Guam is now open for testing. You may schedule your exams online, but please note that appointment availability is limited. The center's current health and safety measures limits test takers to four (4) and hours of operation are limited on specific days.

The **CGFM** Certification Process

1. Read AGA's Code of Ethics
2. Apply for the CGFM Program
3. Submit Required Degree Documentation
4. Receive an Eligibility Letter
5. Prepare for the CGFM Examinations
6. Schedule the CGFM Examinations
7. Take the CGFM Examinations
8. Submit a Work Verification Form
9. Receive your CGFM Award Letter
10. Receive your CGFM Certification and Maintain Your Certification

Preparing for the **CGFM** Examinations

AGA offers several avenues to prepare for the CGFM examinations.

- Examination 1: Governmental Environment (GE)
- Examination 2: Governmental Accounting, Financial Reporting and Budgeting (GAFRB)
- Examination 3: Governmental Financial Management and Control (GPMC)

Candidates can take the Instructor-led training courses; use CGFM Study Guides; and avail the AGA Guam Chapter's CGFM Scholarship programs.

Requirements to Maintain Your **CGFM** Certification

To retain the CGFM certification, all CGFMs must adhere to the AGA's Code of Ethics. In addition, to continue using the CGFM designation after their name, CGFMs must be in an active status.

- Pay the CGFM renewal fee by the due date every year.
- Complete at least 80 hours of Continuing Professional Education (CPE) every two years in government financial management topics or related technical subjects (within the designated two-year cycle).
- Maintain and, if requested by AGA, provide detailed information on CPE hours completed.
- By submitting their annual renewal payment, CGFMs affirm that they have and will continue to abide by AGA's Code of Ethics and that they have fulfilled the minimum CPE Requirements.

AGA Guam's **CGFM** Initiatives

The Chapter has been committed and continues to promote and market the CGFM designation to Government of Guam professionals in the fields of accounting, auditing, financial reporting, internal controls and budgeting, and academia.

The CGFM Committee has various **CGFM** initiatives of the Chapter's continuous commitment to promote the CGFM designation. The following are initiatives that the Certification Committee has in place in its continued efforts to achieve their core mission.

1. **CGFM Scholarship Reimbursement:** Members can receive registration fee plus costs for the three CGFM exams.
2. **CGFM Review Exam Questions Reimbursement Scholarship:** Members can be reimbursed for cost of review exam questions.
3. **Study Guides Loan:** Members can borrow study guide materials as they prepare for their examination.
4. **E-Book (Online) Study Guides Scholarship Reimbursement:** Members can be reimbursed for the purchase cost of CGFM online study guides.
5. **CGFM Mentorship Program:** Provide encouragement to members who signed up in the program to take the exams and attain their CGFM designation.
6. **Study Group:** Committee can facilitate/coordinate a study group upon members' requests.
7. **Monthly or Quarterly Meetings:** Committee can facilitate/coordinate monthly or quarterly meetings with members who are actively pursuing their CGFMs. The meetings will provide a support environment where participants can share their progress, issues they encounter committing to their target goal, study or test taking tips, etc.

CITIZEN-CENTRIC REPORT (CCR)



With the enactment of Public Law 30-127, An Act Relative to Adopting the Association of Government Accountants' "Citizen-Centric Report" Initiative, CCRs are mandated by law to be completed by each government of Guam entity no later than sixty (60) calendar days after the independent audit report for a government entity has been released by the Guam Office of Public Accountability.

Furthermore, Title 1 Guam Code Annotated Chapter 19 §1922(a), every director, administrator, president, or head of a Government of Guam agency, including line agencies, autonomous and semi-autonomous agencies, public corporations, the Guam Mayors' Council, the Courts of the Judiciary of Guam and the Guam Legislature shall submit an annual Citizen-Centric Report: (1) via .pdf email attachment; (2) to the Public Auditor of Guam and the Speaker of the Guam Legislature; (3) no later than 60 calendar days after the release of the entity's independent audit report; and (4) to be posted on the entity's website.

Standards & Guidance - CCR

AGA National provides guidance on how to prepare a visually appealing CCR as well as some samples of completed CCRs.

*Completed CCRs can be emailed to ccr@agacgfm.org, and a team will review and provide constructive feedback on ways to make your report more informative and meaningful. Additionally, AGA National recognizes well designed and informative CCRs with an AGA **Certificate of Excellence**.*
