

NEWS FROM NATIONAL

AGA SEEKING NEW EDUCATION DIRECTOR

Following the late-July resignation of Sherry Crittenden, Education Director in the National Office, the Association has been in the process of selecting a replacement. Applications for the post were accepted through the end of August, and AGA officials expect to hire a new director no later than October 1. EVP Fletcher Lutz has functioned as Acting Education Director during the interim period.

NEW CHAPTER FORMING IN ALASKA The AGA National Office is processing a charter application for a new chapter in Juneau, Alaska. Paul Marz, U.S. Forest Service, was instrumental in forming the group of about 30 charter members of the proposed new chapter. It is expected that AGA's National Executive Committee will formally approve the application at its September meeting. National President Harold Stugart is presently scheduled to preside at the installation of the new chapter on October 18 in Juneau.

TRANSITION TO NEW DUES RENEWAL DATE

As approved by the National Executive Committee (NEC), a procedural change has provided for AGA annual dues renewal to be effective October 1, 1984, and on October 1st each year thereafter. This change modifies the previous system under which member dues renewal dates were staggered throughout the year. In order to transition to the new renewal date, all members were billed in late August for a full year's dues covering the year beginning October 1, 1984. DID YOU KNOW . . .

- The General Services Administration has prepared a handbook designed to familiarize non-A.D.P. managers with details required in planning for and procurement of computers. Entitled The End Users' Guide to Buying Small Computers, the booklet provides step-by-step guidance for managers to avoid wasted effort and uncertainty in complying with Federal procurement regulations. In addition to a discussion of human factors the handbook provides a detailed 10-step process for preparing justification documents with filled in examples of required forms. Among its appendices are a summary of lessons learned from computer acquisition projects in various agencies as well as advice on storage of records on magnetic media. Copies may be obtained from the Office of Information Resources Management (OIRM(KA)), General Services Administration, Washington, D.C. 20405. The telephone number is (202) 566-0291.
- The Office of Management and Budget has recently released a report entitled A Five Year Plan for Meeting the Automated Data Processing and Telecommunications Needs of the Federal Government. This two-volume report concerns the planning process among cabinet agencies, particularly as it relates to managing the evolution of new computer technology. The second volume contains data on the Federal Government's technology acquisition plans from FY 84 through FY 89 as listed by agency and component. This report may be obtained from the Government Printing Office (202) 275-2091.
- A survey conducted by Coopers and Lybrand of corporate internal audit departments in 200 of the For-

- tune 500 companies revealed major changes in the practice and teaching of auditors. Corporate respondents indicated that currently 25 percent of their work is computerized, while five years ago computers were used in less than 10 percent of their work. By the end of the decade computers are expected to accomplish more than 50 percent of all internal auditing functions despite the claim by more than half the respondents that this operation is lagging behind other business applications in the use of computer technology. The major implication according to 9 out of 10 respondents is that integration of computer technology into college curricula is essential. Currently, most respondents felt that there is not enough interaction between auditors and academia to ensure that new graduates receive proper training to conduct audits in which the computer is an essential tool. Accordingly, Coopers and Lybrand has started a pilot grant program to develop revised courses and curricula to include computer applications. This program involves 10 colleges and universities nationwide.
- Four members have been appointed to the recently established Governmental Accounting Standards Board, a body which will establish financial and accounting standards for state, county and municipal governments. The full time chairman and vice-chairman are respectively James Antonio, state auditor of Missouri, and Martin Ives, former first deputy controller of New York City. Two part time members will be Elmer B. Staats, former Controller General, and Phillip L. Defliese, professor of accounting at the Columbia University Graduate School of Business.
