Dr. Perry Moore is Professor of Accounting and Director of Graduate Business at Lipscomb University in Nashville. He is a Certified Public Accountant, a Certified Internal Auditor, a Chartered Global Management Accountant, and is Certified in Risk Management Assurance. A Nashville native, Perry graduated from Lipscomb with a degree in accounting and then completed his graduate studies at the University of Alabama and the University of Georgia.

For the Tennessee Society of CPA's, Perry is a member of their Professional Ethics and Accounting Career Education Committees. Perry has also directed their "Accounting Academy", a program designed to attract high school students to accounting careers. Perry serves as a member of Council representing the Nashville Chapter and as an At-Large Member of the Nashville Chapter's Board.

Perry is active in the Institute of Internal Auditors. He has served as a past-President of their Nashville Chapter. Perry is Past-President of Delta Mu Delta, an international honor society for business majors.

Tammy Waymire, PhD, CPA is an associate professor of accounting at Middle Tennessee State University (MTSU). She joined MTSU this fall following nine years on the faculty at Northern Illinois University (NIU) where she earned awards for excellence in teaching and research. She specializes in governmental and nonprofit accounting topics, both in the classroom and in research. These interests were fueled by her background in public accounting where she audited government and nonprofit entities, and in subsequent roles as a Medicaid fraud investigator and as a public utility regulator. Her research has been published in the Journal of Governmental and Nonprofit Accounting, Issues in Accounting Education, Public Budgeting & Finance, Journal of Government Financial Management, Journal of Accounting Education, and Journal of Public Affairs Education. She currently serves as the President-Elect of the Government and Nonprofit (GNP) Section of the American Accounting Association.

Randall L. Kinnersley, Ph. D., CPA, CGFM, CGMA is a professor at Western Kentucky University (WKU). He earned a Ph. D. from Texas Tech University, a Master of Accounting from the University of Illinois, and a MBA from Eastern Illinois University.

Randy is a licensed CPA in Illinois. His accounting career began in health care and he ultimately served as a Director of Finance (chief financial officer) for a government-owned hospital before he began his academic career. Randy has spent more than 30 years in academia with governmental accounting as his primary interest.

Randy has served on Nashville Chapter Executive Committee. He was the Nashville Chapter Early Careers Chair for two years and also served on a southeast regional professional development conference planning committee. Randy was a member of the Government Performance Accountability Committee of the AICPA for three years and currently serves as the government accounting expert on Financial Accounting and Reporting (FAR) content sub-committee of the CPA exam for the AICPA.

Dan Wesley Meyer, Ph.D., CPA works as an associate professor at Austin Peay State University since 2004. He previously taught at Indiana University East, Jasonville State and University Tennessee at Chattanooga. He also worked at Seidman and Seidman and Memphis Moore and Gray. He received a bachelor's degree at the University of Mississippi, master's degree at Purdue University and doctorate degree at the University of Missouri. He is the author of several publications and is a Certified Public Accountant.

Thomas W. De Berry graduated with a B.S. in Accounting from Lubbock Christian University and a M.S. in Accounting from Texas Tech University. He has been a C.P.A. (Texas certificate) since 1980. Tom worked for several years in Dallas, Texas and the Los Angeles, California area in the electric utility industry. He completed his Ph.D. in Economics from Texas Tech University, while on the faculty of Lubbock Christian University. He became a Certified Fraud Examiner in 2007. He has taught a wide variety of courses in accounting, economics, and fraud examination for Lubbock Christian, University of North Georgia, and Freed-Hardeman University.


The Nashville AGA Year in Review — Mary Lou Goins

Does Nashville AGA make a difference? A quick review of the statistics of membership points makes one think about how AGA makes an impact upon its membership. Do members belong to AGA just because they want to say they belong? Do they come to the meetings? Do they attend the training offered? Do they participate in the community service opportunities? How many participate on the various committees?

Currently Nashville AGA has a membership of 365 members, 73% of the membership earned some type of points during the previous year. Of those earning points, 65% of those earned less than ten points as indicated with the chart.


Nashville has nine regular meetings during the year. 204 members, or 56% of the current membership did not attend a meeting during the year. If you do the math, that makes 44% attended a meeting or 161 members. Only 1% or 5 members attended all nine meetings while 12% or 45 members attended a meeting only once during the year. Seven of those meetings are CPE meetings for members to earn an hour of continuing professional education. Thirty-one guests were brought to the meetings and six new members were sponsored by existing membership.

Nashville AGA has always been known for great Community Service participation, however only forty-one of it's membership or 11% participated in at least one community service activity. There were some great opportunities presented for each of us to participate. Of the points being earned the prior year on the various community service activities the National Public Television drive received the highest for points earned. As we begin a new year each member of Nashville AGA needs to remember that we are to be engaged in service to our community and strive to improve the participation in the coming year.



Committee participation is vital to any organization. There are sixteen various committee opportunities in AGA which include: Awards, Education, Internet, Meetings & Attendance, CGFM, Newsletter, Membership, Early Careers, Program, Community Service, Public Relations, Accountability, Finance, Sponsorship, CEC, and Regional and National Committees for members to serve. Only 12% of the current membership received points for serving on a committee. Volunteer to serve, it will help Nashville AGA to grow.

Training participation is the highest participation for any AGA points received during the year. 51% or 185 members of Nashville AGA participated in the training offered through AGA and seven of the members were featured speakers. AGA is a great place to obtain continuing education credits for CGFM and CPA. Are you taking advantage of those opportunities?
