### Board Member Spotlight: Brian Frey

AGA Communique's Board Member Spotlight series will feature an interview with a different board member each month. For the December 2021 issue, we interviewed Brian Frey, Education Co-Chair.

**Matt Dragonette**, Newsletter Editor (Q). Tell us about your career to-date.

**Brian Frey**, Education Co-Chair (A) I am still in the early stages of my career, a little over 4 years out of college, but so far, I have worked entirely in the government industry. I am a senior auditor in KPMG's federal audit practice, and I have experience working on the audits of both civilian and defense agencies.

Q: Can you tell us about your service on the board? How did you get involved and where have you been able to contribute?

A. I began serving on the Montgomery/Prince George's board in 2018 after I was encouraged to take on a more active role by one of my coworkers. I served as a co-chair of the Young Professionals committee for three program years. I enjoyed working on the Young Professionals committee because it afforded me the opportunity to put on programming for other individuals who were in a similar spot in their career. I especially enjoyed the outreach that we did on college campuses, including presenting to government accounting classes, because we got to expose students to careers in government accountability. I recently transitioned to co-chair of the Education committee, and

so far, I have enjoyed helping to bring engaging CPE events, covering a diverse array of topics, to our members.

Q: What's been the best aspect with AGA with respect to your career development? Are there any membership benefits you have particularly enjoyed?

A. I have really enjoyed the CPE meetings that I have been able to attend over the last few years. The chapter does a great job of recruiting speakers with A. My favorite AGA memory was presenting to a government accounting class at the University of Maryland a couple years ago. The students were so inquisitive and asked insightful questions about the benefits of a career in the government industry.

Q: In 2020-2021, you were recognized with the Chapter Special Achievement award for your contributions to the young professionals program and chapter outreach. Can you tell us a little about the award itself and

I was only about a year into my career and not sure what I would be able to offer the chapter. ## **Recent Accounting & Reporting Updates**

### A snapshot of federal, state, and local changes.

### **Government Accounting Standards Board**

In October 2021, GASB renamed "the most extensive report prepared following its standards" to be the annual comprehensive financial report (ACFR). No other changes were made to the ACFR, but the name was changed due to the offensive nature of the prior acronym when spoken aloud. *See gasb.org for the released media advisory.* 

In November, the Financial Accounting Foundation (FAF), which oversees GASB, announced four new board members for the upcoming five year term beginning January 1, 2022. The new members are Trustees Manju Ganeriwala, Edward (Ted) J. Goldthorpe, W. Bryan Lewis, and Diane C. Nordin. #### Federal Accounting Standards Advisory Board

In November 2021, FASAB issued Statement of Federal Financial Accounting Standards (SFFAS) 60: *Omnibus Amendments 2021.* This standard amends SFFAS 54: *Leases* for technical corrections and clarifications. During this period, FASAB also issued Technical Release 20 (leases) and Interpretation of Federal Financial Accounting Standards 11 (debt cancellation).

In December, FASAB appointed Raymond Vicks and reappointed Patrick McNamee to the FASAB.

AGA selected the National Science Foundation (NSF) as the winner of the 2021 Innovation Challenge for its Financial Obligation Root Cause Explorer (FORCE). NSF's FORCE "uses a fully operational artificial intelligence and machine learning technology stack of data aggregation, visualization, natural language processing/text analytics, and dashboard platforms" to analyze NSF's repository of grants. ### 2021 Inspectors General Survey:

AGA performed a survey of federal inspectors general to identify challenges facing the IG community. Participants reported ongoing challenges and successes related to oversight of pandemic spending and the government's response to the pandemic.
