Since we won't be together for our meetings and hold these events for the near future, I've researched some ideas on the internet on how we can help our community while social distancing.

> Check on your neighbors.

Call or text your neighbors (especially elderly neighbors) to make sure they're doing okay. Ask if there is anything that they need (be it a box of tissues or a cup of sugar). If you have what they're looking for, offer to leave it outside their front door so that they can pick it up without coming in direct contact with you. It sounds extreme, but this is a great (and safe) way to make sure that your more vulnerable neighbors have what they need. If you feel comfortable going out, consider knocking on the door of any elderly neighbors and chatting through the screen or storm door just to offer a bit of comfort and reassurance.

- > Explore ways to connect and volunteer virtually.
- > Waste not, want not.

For many of us, the first of many mad dashes to the grocery store happened a while back. And if we're lucky, our pantries, freezers, and fridges are stocked with the necessities (and maybe even a few treats). But as grocery store shelves continue to empty, we can't keep counting on restocking as usual, and so it's very important that we use (cook it, eat it, share it, store it) what we have.

> Remember those who are still out there on the front lines Though it may be hard to imagine, at some point, the pandemic will subside and we'll be able to slowly get back to our lives. And once we're on the other side of this crisis, we're going to have a whole lot of people to thank.
