- ❖ Discussed minutes of the February 15, 2017 meeting. Meeting minutes were approved as amended to reflect adding that minutes were approved 1st by Nicole, 2nd by Walt; all in favor.
- ❖ Upcoming Chapter events: Apr 20 – KPERS representative will present information. It will be a 1 CPE event w/lunch included. May 17 event details still undecided on details. June 14th will be another chapter event; final details undecided to date.
- ❖ Nicole presented the Board with the February Monthly Financial report. The expenditures were \$4.82 for Card Services (2/9), \$198.00 for renewal of USPS PO Box rental (2/9). No invoices received to date from Scott from Feb event or from Jayhawk Hotel for Jan/Feb/Mar events. The net positive will be \$480 after Feb invoices are paid.
- ❖ Discussed information available on free webinars (usually 4 to 6 per year). National AGA advance notice – need to watch for notices.
- ❖ Proclamation from City of Topeka was not able to be placed on agenda for March, but it is on State of KS, Riley and Shawnee Co, and City of Leavenworth provided proclamations.
- ❖ Award Time – Newsletter/Minutes/Welcome – Mar 31 deadline. Website challenge – not doable this year. Provide template to Secretary so she can draft an application for Education and Community Services for the Chapter.
- ❖ Chapter Recognition – Quarterly review.
- ❖ Need to choose new organization for Loose Change Jar Donation - Apr/May/Jun.
- ❖ The next meeting is scheduled for April 19, 2017 and will be held at Norsemen Brewing at approximately 5:15pm.
- ❖ The meeting was adjourned at 7:00pm.

KPERS—What you need to know BEFORE you retire!

This presentation was held in the Florentine Room of the Jayhawk Building on April 20, 2017. Our speakers represented different aspects of KPERS services. **Allen Conroy, Executive Director of KPERS** provided an overview of changes in KPERS, the current status of KPERS unfunded liability, and discussions at the Executive and Legislative leaders regarding state employee retirement plans.



Dianna Berry, KPERS Manager of Education and Training, provided an overview of the three existing employee plans, which vary depending upon the date when an employee first becomes a member of KPERS. Generally, retirement is possible when an employee's age and years of service totals 85. However, early retirement is possible under certain circumstances. Critical decisions must be made upon retirement, which cannot be changed once retirement occurs. Dianna recommended that employees become familiar with the details of their plan and the options they must decide upon when they retire.

Faith Loretto, KPERS 457 Plan Manager, explained the new 457 plan and the flexibility of the plan that allows employees to manage their savings. While the plan was previously managed by private companies, the Legislature decided that KPERS history of positive returns made them the best choice for managing the “deferred compensation” plan for the State. No longer do you need to be concerned that the person you are looking to for advice is looking to reach a sales quota. The plan advisors are now fellow state employees who do not earn commissions from sales.
