Consider studying and taking the tests to become a Certified Government Financial Manager (CGFM).

Having this certification gives you a leg up when seeking promotions.



AGA's CGFM program was specifically designed to emphasize the unique qualifications and stature of government financial managers. It recognizes skills and advanced knowledge required of those in the field. CGFM candidates must hold at least a bachelor's degree from an accredited college or university. And, in addition to passing three rigorous examinations and meeting an experience requirement of professional-level work in government

financial management. CGFMs agree to abide by AGA's strict Code of Ethics and complete at least 80 hours of continuing professional education in government financial topics, or related technical subjects, every two years. Historian's Corner, Janice Evans:

Do you remember when Des Moines AGA held monthly meetings at various times and locations?

The December 2020 AGA Ledger reflected on meeting locations between 1979 and 1989. The June 2021 reflected on the 1990's and this newsletter will complete the meeting location history.

The 2000's started with locations that either served lunch or it was easily accessible and most meetings for the year were held in one or two locations. These meeting locations included the State Historical Building, the Lucas Building 6th Floor Cafeteria, the Lucas Building State Auditor's Office Training room (food available in the cafeteria), the Cub Club (lunch buffet), the Botanical Center, Noah's Ark Ristorante (RSVP with choice from three items), and the Mercy Capitol Hospital Cafeteria (now green space).

Starting in Fall 2009, attendees could either order a box lunch from Quiznos or bring their own. The Quiznos option was discontinued in 2011 and members brought their own lunch except for the complimentary pizza to celebrate CGFM month. Some years included an occasional supper meeting at local restaurants such as Baratta's, Mezzodi's, Johnny's Italian Steakhouse, Okoboji Bar and Grill, and Latin King.

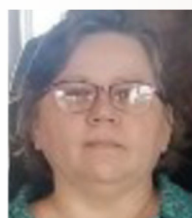

President's Message – December 2021

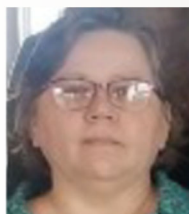

Historian's Corner, Janice Evans:

Do you remember when there was a Midwest Regional Financial Management workshop at Tan-Tar-A Resort on Missouri's Lake of the Ozarks and strategic planning was the rage? I was fortunate to attend a couple of the workshops and the resort is beautiful (though it was cold in November) and the training was great. The following are excerpts from an article on strategic planning written by Steve Bolie, AGA Des Moines President Elect from the December 1990 Newsletter after attending one of the workshop sessions.



Strategic planning is the rage in business and government these days. In government and non-for-profit the list of constituencies is more difficult than in for-profit but, strategic planning is more important and works better in the government and not-for-profit arena.

Strategic planning is a continuous process which helps an organization focus its key factors on its primary purpose. The initial planning stage instills strategic thinking into an organization so that each part of the organization evaluates its activities according to the goals of the organization. Following are four sets of questions that add up to strategic planning.

- What business are we in? What set of needs are we equipped to meet?
- What markets (constituents do we serve?)
- What products/services does our organization bring to the market?
- What differentiating style does the organization wish to be known by?

The February 1984 Des Moines AGA Newsletter requested nominations for the following awards with their descriptions. 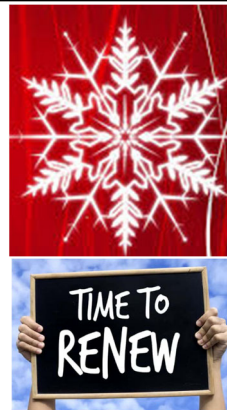

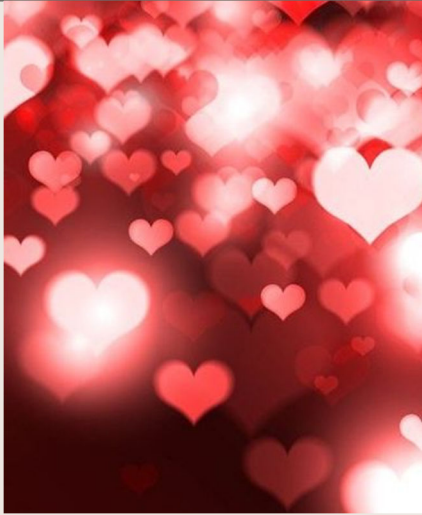

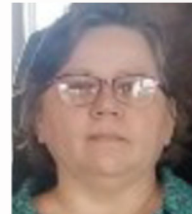
President's Message – April 2022

2022 Spring Seminar

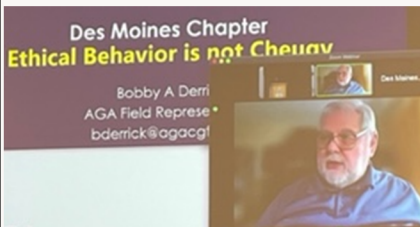

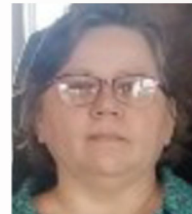
President's Message – June 2022

Historian's Corner, Janice Evans:

Do you remember when Iowa had a State Comptroller's Office and Ron F. Mosher, CPA, State Comptroller spoke at the June 4, 1979 AGA meeting on "You Can Help Cut Taxes"?



Following is a portion of the meeting notice from the June 1979 newsletter.

Ronald F. Mosher is the State Comptroller for Iowa. As the chief financial officer of the state, his primary responsibility is to provide advice to the Governor on all aspects of government finance. The Comptroller Office includes the functions of accounting, budgeting, data processing and labor

It appears the State Comptroller's Office was eliminated during the 1986 legislative session and duties went to the Department of Management, the Department of Revenue and Finance, and the Department of General Services. The following are excerpts from the Iowa Legislative Service Bureau's publication [Summary of Legislation, Iowa General Assembly 1986 Session](#).

The Department of Management assumes most of the responsibilities of the State Comptroller except for accounting and tax credit disbursement functions which are transferred to the Department of Revenue and Finance, and the data processing function which is moved to the Department of General Services. The State Comptroller functions, which the Department of Management will perform, include pre-audit of claims, warrant issuance, and contract reviews. Functions the Department assumes from the Office for Planning and Programming include planning and budget preparation. The State Appeal Board becomes a part of the Department, and the State Comptroller's position on the Board is replaced by the Director of Management.

The name of the Department of Revenue is changed to the Department of Revenue and Finance to reflect the Department's assumption of the State Comptroller's accounting and tax credit disbursement functions and the Lottery Agency.

The current Department of General Services assumes additional responsibilities which include: coordinating building and office space leasing for all state agencies; providing communications services; and coordinating data processing (assumed from the State Comptroller).
