### Carol-Ann Boothe, President-Elect, MPGC

Poised to lead in July 2025, Carol Boothe has already made a mark through her strategic leadership and dedication. In the interview below, she reflects on her current role and shares her vision for the chapter's future.

### As you wrap up your term as President-Elect, what are some contributions you've made this year that you're most proud of?

I am proud to have organized and facilitated the Risk Management CPE session hosted at the IMF, which drew over 100 participants in-person and virtually, highlighting cross-sector leadership and engagement. I also played a key leadership role in planning and delivering the 2025 Spring Workshop in Washington, DC, partnering with organizations including NABA, IMA, AGA NOVA, and ACCA to offer a dynamic program and achieve record attendance.

### In what ways have you supported the current President and the chapter board throughout this program year?

I supported the board by facilitating board meetings during the President's absence, actively participating in all board activities, obtained Allmond & Company as a new sponsor, and working closely with the Treasurer to ensure the timely preparation of the past two years' financial statements, strengthening our chapter's financial governance.

### Can you share any behind-the-scenes efforts or planning you've led in preparation for your upcoming role as President?

I have been actively engaging with other AGA chapters, professional organizations, and student groups to set the groundwork for collaborations. I've also been developing strategies to tailor events to specific federal and local government agencies, broaden outreach to nonprofits

### As you prepare to take on the role of Chapter President in July, what are some key goals you've set for the year ahead?

Key goals include: (1) increasing membership among students, nonprofit professionals, and state and local governments, (2) strengthening partnerships with other chapters and associations, 3) increasing the list of sponsors, and (3) customizing programming to specific agencies and sector interests to drive greater member engagement.

### Are there any new initiatives or programs you're planning to introduce during your term?

### **FASAB Updates**



Here is a summary of the Federal Accounting Standards Advisory Board (FASAB) updates and standards issued within the last 90 days (January–April 2025):

AAPC Becomes ASIC (February 3, 2025)

The Accounting and Auditing Policy Committee (AAPC) has been restructured and renamed as the Accounting Standards Implementation Committee (ASIC). This change reflects an updated governance framework aimed at enhancing the implementation of federal accounting standards.

No other new standards or technical releases have been issued by FASAB within the past 90 days. However, several significant pronouncements became effective for fiscal years (FY) 2025 and 2026:



Effective for **FY 2025** (Reporting Periods Beginning After September 30, 2024):

- **SFFAS 54: Leases** Establishes a comprehensive lease accounting model for federal entities, requiring recognition of lease assets and liabilities. This standard is effective for reporting periods beginning after September 30, 2023.
- SFFAS 57: Omnibus Amendments 2019 (paragraphs 3–8, 11, and 12) Provides clarifications and updates to existing standards, including those related to leases.
- SFFAS 60: Omnibus Amendments 2021: Leases-Related Topics Addresses lease-related topics to ensure consistency across standards.
- SFFAS 61: Omnibus Amendments 2023: Leases-Related Topics II Further refines lease accounting guidance.

### **FASAB Updates**



- SFFAS 62: Transitional Amendment to SFFAS 54 Provides transitional guidance for implementing SFFAS 54.
- **Technical Releases and Bulletins Related to Leases** Includes Technical Release 20, Technical Release 22, and Technical Bulletin 2023-1, which provide implementation guidance for lease accounting.

Effective for FY 2026 (Reporting Periods Beginning After September 30, 2025)

- SFFAS 64: Management's Discussion and Analysis Rescinds and replaces SFFAS 15, updating the framework for Management's Discussion and Analysis (MD&A) to enhance clarity and relevance. Effective for reporting periods beginning after September 30, 2025 (FY 2026). Early implementation is permitted.
- SFFAS 59: Accounting and Reporting of Government Land Transitions required supplementary information (RSI) on land to basic information within note disclosures. Effective for reporting periods beginning after September 30, 2025 (FY 2026). Early adoption is not permitted.




