Community Service January

In 1975, the Chattanooga Rescue Mission was founded by a group of men who had a burden to reach a segment of the population which no other ministry could reach—the homeless of Chattanooga. During that time, we have provided an estimated 400,000 meals and 350,000 beds for the homeless.

Originally the Mission bore the name of the Jubilee Ministries. That name was changed to the Maranatha Rescue Mission, and then again in 1999 to the Chattanooga Rescue Mission, so as to reflect the broader outreach the Lord has enabled the Mission to have over the years.
