## In Other News...



AGA offers candidates multiple options when it comes to preparing for the CGFM exams. As mentioned in last month’s post, study guides are available. You can purchase a print version or use the online study guides (remember our chapter has the online version for use by members). In addition to study guides, candidates can register courses tailored to each exam. Currently, AGA offers live training sessions held virtually, self-paced training course accessed online, or classroom training held in-person. If you are seeking your CGFM with others, you can even schedule a private training session. Registration costs and dates for the training courses vary and I would encourage you to explore each option to see what best meets your needs. Once you are ready to test your knowledge, AGA also offers practice exams.

### Misty’s CGFM Certification Journey

Personally, I knew I would benefit most from a live instructor led course. Attending in person was not an option for me so I chose to register for the virtual live course. Course 1 “Governmental Environment” was held over two days, with each session lasting 4 hours. The online platform made it easy to ask questions and I was able to track along with the instructor in my study guide. I work in the federal capacity and the instructor provided much-needed context for me in state and local government. I finished the course feeling more prepared and with a better sense of where I should spend additional time studying. As I prepare to schedule Exam 1, I’m hoping it’s enough.
