Season of Success! 2018 CGFM Exam Promotion

CGFM candidates, take any CGFM exam in August or September and receive a promo code for 50% off any CGFM exam taken before the end of the year.

Here's how it works:

- 1. Take any CGFM examination between August 1 and September 30, 2018.
- 2. Receive a promo code via email, which will give you 50% off the price of your next CGFM examination
- 3. Schedule and take your next CGFM exam using the promo code by December 31, 2018.

Terms and conditions:

- A promo code will be <u>automatically</u> issued to all current CGFM candidates who take a CGFM exam between 8/1/18-9/30/18, and who still have to pass at least one exam.
- Promo codes will <u>only</u> be emailed to candidates on the following dates:
 - 8/15 for exams taken 8/1-8/14,
 - 8/31 for exams taken 8/15-8/30,
 - 9/17 for exams taken 8/31-9/16,
 - 10/1 for exams taken 9/17-9/30.
- The promo codes are <u>not</u> exam specific and can be used towards any of the three CGFM exams, as long as they are scheduled to be taken by 12/31/18.
- Each candidate will receive one promo code for <u>each</u> exam taken in the August-September timeframe. Candidates who take more than one exam during the timeframe of 8/1/18-9/30/18 will receive more than one promo code. No promo codes will be issued for exams taken before or after this period.
- To receive the 50%-off discount, promo codes must be used prior to payment when scheduling an exam
 online or over the phone with Pearson VUE. Adjustments to the exam price will not be made once the exam
 is scheduled or taken.
- Candidates do not have to pass an exam in the August-September timeframe, in order to receive a promo
 code.
- Promo codes are nontransferable and have no monetary value.
- To utilize the promo code, candidates must schedule and take their exam by 12/31/18. The expiration date of 12/31/18 will not be extended for any reason. Testing centers may fill up candidates are encouraged to schedule their appointments with the promo codes as soon as possible.

Do you remember when there were less than a dozen Governmental Accounting Standards Board (GASB) statements and state legislation regarding deficit balances was passed? The following President's message written by Calvin McKelvogue was in the December 1992 AGA Ledger.



The Governmental Accounting Standards Board (GASB) is currently deciding the fate of the implementation of Statement No. 11, Measurement Focus and Basis of Accounting for Governmental Funds. As originally scheduled, this Statement would have been effective for the State's 1995 fiscal year, but the GASB recently voted to delay the implementation date for an indefinite period. This Statement has major ramifications upon governmental accounting, basically moving from a modified accrual basis of accounting to an accrual basis.

In the past year the Iowa Legislature passed legislation that requires the State to eliminate the GAAP deficit by the end of FY 95 by actually eliminating some GAAP accounting problems and using the material positive impact the State will get from the implementation of Statement No. 11. So as you can imagine, we are currently monitoring the GASB's activity related to this project and are attempting to work with the GASB to develop some alternatives so that we can still meet our FY 95 goal of eliminating the GAAP deficit.

Do you remember when the minimum wage was \$3.80 or the subminimum wage was \$3.35? The following article was in the April 1991 AGA Ledger.

MINIMUM WAGE GOES UP APRIL 1

For employees subject to the federal wage-hour law, a new minimum of \$4.25 takes effect as of April 1.. Since last April 1, the minimum hourly rate has been \$3.80. The subminimum wage, which employers are permitted for a limited period to pay newcomers to the labor market, age 16-19, goes up to \$3.61 from \$3.35.

The minimum wage was enacted in the United States in 1938 as part of the Fair Labor Standards Act. The first minimum wage was 25 cents an hour. The federal minimum wage of \$7.25 per hour has not increased since July 2009. The Department of Labor's website indicates the state minimum wage for 29 states exceeds the federal minimum wage, 16 states are the same as the federal minimum wage, and five states have no minimum wage.

Do you remember AGA's Office of Minority Business Enterprise Courses (OMBE) Program? The May and June 1979 Des Moines AGA News listed topics for the 1979 National Symposium (now PDT) held in St. Louis in June 1979, which included various issues in accounting, auditing, internal controls, time management and the OMBE Program. The following infor-



mation about the OMBE program is from National AGA's website.

September 1974 – OMBE program enters its third year of providing training to minority businessmen in 10 cities across the country. June 1976 The OMBE program continues with 30 chapters participating and 42 courses offered. AGA signs fiscal year 1977 contract with the Department of Commerce. April 1977 - June 30, 1977 marked the fifth anniversary of the AGA/ OMBE program. January 1978 - Despite a sizable cut in the funding of this year's contract, AGA will maintain approximately the same number of OM-BE courses as last year. **May 1978**, AGA was seeking a director of socioeconomic activities in the National Office to oversee the OMBE program and other similar programs that may develop. August 1978 - A new record was set with 50 OMBE courses offered. April 1980 – The OMBE is replaced in the Department of Commerce by the Minority Business Development Agency (MBDA) and while Commerce indicates it does not intend to abandon the minority small business community, it seems clear that its level of support will be less than it has been in the past. How this will affect AGA's grant to provide local training to minority business people is unknown. September 1980 – MBDA training is put on hold as AGA seeks other sources of funding after a shift in the Department of Commerce's priorities result in the agency's failure to renew AGA's grant. **October 1980** – The National Executive Committee (NEC) approved a plan to continue the MBDA program in conjunction with the New School of Social Research in New York. March 1981 - The NEC made sharp cuts in AGA's operating budget to offset impending deficit at the end of the year, due partially to the loss of the MBDA grant. It appears that ended the OMBE/MBDA program.
