MEET JOSEPH HUNGATE, NOVAGA'S INCOMING PRESIDENT



Q1: Tell us a little bit about yourself and your career.

A: I was born in San Antonio at Brooke Army Hospital but moved to Columbia, South Carolina at a young age and stayed close to home for college earning my bachelor's and master's in computer science at the University of South Carolina. I have three adult daughters and live with my wife, Michelle, in Arlington, Virginia.

I joined RMA Associates in January 2022 after retiring last year after 28 years of US Government service. I served as the Centers for Disease Control and Prevention (CDC) Deputy Chief Financial Officer and led several CDC financial systems technology transformation efforts. I have held leadership roles in U.S. Department of Housing and Urban Development (HUD), U.S. Department of Treasury's Inspector General for Tax Administration (TIGTA), and the US Department of Commerce (NIST & OIG) as well as positions in the private sector. My successes have enabled me to earn a Presidential Rank Award of Meritorious Executive for IT innovation in 2005 and the 2018 Department of Housing and Urban Development Secretary's Award for Distinguished Financial Stewardship and Accountability.

Q2: What was one of your first jobs and how did it shape your career?

A: My first job, other than yard work was at Piggy Wiggly Grocery Store. I was fortunate that the owner/manager was a strong believer in developing his employees. I was afforded many different job

experiences starting as a grocery bagger, quickly leading to stock person, cashier, and butcher assistance opportunities. I learned that doing a job well led to greater responsibilities and more complex positions.

Q3: How did you get involved with the AGA and NOVAGA chapter?

A: It was nearly 20 years ago when I was invited to speak on telework at an AGA event. The professional interaction and the ability to share and gain knowledge focused on government were very appealing, and I have participated ever since. A long-standing member of the DC Chapter due to employment location, I recently moved to NOVAGA when I began working at RMA Associates based in Northern Virginia. 'Without a deep



Federal Financial Partnership Award

In 2003 the Northern Virginia Chapter of AGA instituted the Federal Financial partnership Award to formally recognize private sector individuals who exemplify and promote excellent through outstanding leadership, high ethical standards, innovative management procedures and partnering with the Federal Government. The award recognizes the cumulative achievement of private sector professionals who throughout their career have served as a role model for others and who have consistently exhibited the highest personal and professional standards. Nominees must be employed by the private sector but do not have to be AGA members.

The first recipient of this award was John. H. Hummel; in 2019, it was awarded to Mike Frederickson, RMA Associates.

The Pentagon Memorial Service Award

The award was established in 2002 in memory of the victims of the September 11, 2001 attack on the Pentagon. The award formally recognizes public service to our nation in the field of financial management. The award recognizes dedication and commitment to improved government operations, financial stewardship and accountability through public service to our nation. Nominees must be a civil servant (federal employee) or a member of the Armed Forces, however, nominees do not have to be members of AGA.

The first recipient of this of this award was LTC Christopher Keefer, U.S. Air Force; in 2019, it was awarded to Shawn Sparks.
