



DDS is seeking an experienced accounting professional who is detail oriented, with advanced knowledge of more complex accounting principles and procedures, and possesses a high degree of initiative. As a Staff Accountant at DDS, you will:

* allocate charges and credits to proper accounts;

* interpret State and departmental policies, procedures and regulations as well as those of the Social Security Administration;

*** Experience must demonstrate comprehension and application of Generally Accepted Accounting Principles (GAAP) and Governmental Accounting Standards Board (GASB) guidelines and must demonstrate the ability to (1) classify and analyze financial data and records for the purpose of business financial planning; (2) design, recommend, and implement modifications of accounting methods, procedures, forms, and records; (3) prepare financial statements and reports such as balance sheets and other operating statements; and (4) analyze accounts and accounting relationships that result in complex accounting entries.

- **Examinations** pass three comprehensive CGFM Examinations.
- **Experience** have at least two years of professional-level experience in government financial management.

On April 12, 2016, the Maine Chapter of the AGA met at the Senator Inn located in Augusta. Chapter President-Elect, Shirley Browne, welcomed the Chapter. She proceeded to introduce her colleague and friend, Eric S. Berman, MSA, CPA, a Partner at Eide Bailly, LLP who was gracious enough to accept our invitation to speak to the Chapter.

Mr. Berman has a Master of Science in Accountancy and a Bachelor of Science in Broadcast Journalism and holds several certifications. He has served on multiple committees and councils and has a broad knowledge of finance and policy. His most recent endeavor is presenting on Cyber-security.

Through his great presence and relatable content, Mr. Berman spoke on "Building a Culture of Security". How do firms gather the information they need regarding risk to their data, how do they interpret that information and how to do implement change? As they say, it is better to be proactive and reactive. NIST (*National Institute of Standards and Technology*) has created a sample framework around the risk of losing data, which involves the processes to "**Identify** (understanding the risk to systems, assets, data and capabilities)", "**Protect** (safeguards to ensure delivery of critical infrastructure and services)", "**Detect** (activities to identify occurrence of cybersecurity event)", "**Respond** (activities to take action regarding detected cybersecurity event)" and "**Recover** (activities to maintain plans for resilience and to restore capabilities or services impaired due to cybersecurity event)".
