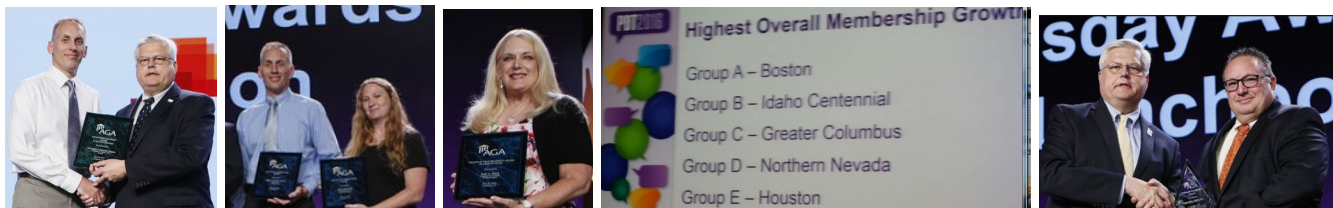
AGA NATIONAL PDT
