## Edward J. Mazur



Edward J. Mazur currently serves as Senior Advisor for Governmental Financial Management for Cherry, Bekaert & Holland. He has served on both the Governmental Accounting Standards Board and the Federal Accounting Standards Advisory Board. Mazur was

confirmed by the U.S. Senate in 1991, to be the first Controller appointed by the President under the Chief Financial Officers Act of 1990, and headed the Office of Federal Financial Management within the Office of Management and Budget.

He served four Governors as State Comptroller for the Commonwealth of Virginia between 1980 and 1991, and as President of the National Association of State Auditors, Comptrollers, and Treasurers, and the National Association of State Comptrollers. During his career, he has also served in the Washington office of the American Institute of CPAs, and in senior financial management positions with Virginia State University and Virginia Commonwealth University. He is a Certified Public Accountant, and holds an MBA from Wharton and a BS degree in Mechanical Engineering from the University of Connecticut.



## An Overview of the FY2010 SF-133

### Background

The Office of Management and Budget (OMB) is currently working on new formats for the SF 133 Report on Budget Execution, SF 132 Apportionment Schedule, and the Statement of Budgetary Resources (SBR). These new formats will bring these reports into closer alignment with the Programming and Financing (P&F) Schedule. The new SF-133 format will be required in FY2010 and is markedly different from its predecessor, while Circular A-136 indicates that the related SBR won't change until FY2011.

### Sections

One thing that has changed only a little on the SF-133 are the sections, though some of the new names are longer and there is a new section. The format that becomes effective for FY2010 has the same four sections as the old format, but uses the names Schedule of Budgetary Resources; Status of Budgetary Resources; Change in Obligated Balance; and Budget Authority and Outlays, Net. A new Schedule of Unfunded Deficiencies will be found at the bottom of the report. It is not clear how many agencies will use the new section, in part because the Standard General Ledger (SGL) account mapping has not yet been defined.

### Line Numbers

The line numbers are completely different. Instead of alternating numerals and letters so that one has awkward numbers like 3D1b, the new line numbers are four digits. The first digit indicates the section number, except that the new fifth section uses line numbers beginning with 7. There are also a lot more lines than previous, 177 versus 56 under the current format (excluding header and total lines).

### Line Mapping

There are only 16 lines which map one-to-one from the current to the new format. The starting unobligated balance brought forward on line 1A and will be on line 1000. Actual recoveries on 2A will be on 1021. Cancelled authority on 6A will be on 1029. Anticipated transfers on 4D will be on 1040. Anticipated recoveries on 2B will be on 1041. Anticipated apportionments on 9A3 will be on

2182. Unobligated balances not available, currently on lines 10A, 10B, and 10C will be on lines 2200, 2201, and 2202, respectively. Beginning unpaid obligations on lines 12A1 and 12A2 will be on 3000 and 3001. Beginning uncollected federal customer payments on lines 12B1 and 12B2 will be on 3010 and 3011. Gross outlays on line 14 will be on 3040. Ending unobligated balance on lines 18A and 18B will be on 3090 and 3091.

Obligations incurred are currently split out by reimbursable and direct. That distinction goes away in FY2010. All Category A funded spending, currently on lines 8A1 and 8B1 will be on line 2000 (though there is a note that it will be split out by quarter, so possibly lines 2001-2004 will be used). Category B spending (lines 8A2 and 8B2) will continue to be split out by project, using lines 2011 through 2169 as needed. Spending from funds not subject to apportionment, currently on lines 8A3 and 8B3, will be on line 2170.

In most cases, however, one line of the current SF-133 maps to several in the new format. All funding and withdrawals will be split out between the discretionary and mandatory Budget Execution Authority (BEA) categories. Appropriations currently on line 3A1 will be split out across 16 lines (1100-1108 for discretionary and 1200-1206 for mandatory) in the new version. In addition, individual SGL accounts can be split across as many as eight lines in FY2010, using such elements as Authority Type, BEA Category, Fund Type from FACTS II, Advance Flag, and Debit/Credit flag. Agencies should examine their current appropriations and determine if they need to be reported on multiple lines of the new SF-133, and if so, decide which data elements from their own system will be used to make those distinctions.

Borrowing authority activity, which is currently on line 3B, will be reported in the 1300 series for discretionary and 1400 for mandatory funds. Similarly, contract authority from 3C will be in the 1500 (discretionary) and 1600 (mandatory) series, and offsetting collections from 3D will be in the 1700 (discretionary) and 1800 (mandatory) series. The anticipations and reductions to authority currently reported on lines 4 through 6 will be split out by the type of authority throughout the first section.

The second section (current lines 8-10) will be relatively unchanged and was discussed above. The third section has only minor changes, most notably that obligations incurred (line 13, will be 3030 and 3031), uncollected federal payments (line 17, will be 3050 and 3051), and recoveries (line 16, will be 3080 and 3081) will be split out between expired and unexpired fund symbols. Also, actual transfers (currently 15A and 15B) will be split out between transfers to and from others.

Section four on outlays will have much more detail. It will not only split out activity between discretionary and mandatory BEA categories, but outlays will be reported by new and existing authority separately, and offsetting collections will be divided among five lines. Many of these lines use the same SGL accounts, relying on BEA category, Transaction Partner, and Fund Status to determine which amounts are reported on which lines, so again, agencies should review their activity and decide how to report it in the new format. This section will also include a recap of some data from current lines 4B, 6F, and 17 to calculate net budget authority.

The new section five describes activity for deficiencies. I assume this is the type of activity that currently uses SGL Accounts 4112 Liquidation of Deficiency - Appropriations and 4212 Liquidation of Deficiency - Offsetting Collections, and so would not be needed by most agencies. However, as of the time this is written, the guidance has yet to be issued.





# Stimulus reporting registration off to a smooth start

Nearly 3,000 recipients of Recovery Act funding have signed up for [FederalReporting.gov](http://FederalReporting.gov), a Web site that will collect governmentwide data on stimulus spending.

The first two days of registration for prime recipients, subrecipients and federal agencies were free of major hiccups, according to Ed Pound, a spokesman for the Recovery Accountability and Transparency Board, which runs the Web site. "This is a good start," he said. "We did not have any glitches so we know it's working right."

Enrollment, which began on Monday, is the initial reporting step for state and local governments, contractors, universities, nonprofits and other organizations that have received stimulus grants, contracts or loans of more than \$25,000. As of early Tuesday afternoon, 2,900 funding recipients completed a one-time registration with the password-protected site, Pound said.

FederalReporting.gov is modeled after an open source approach developed by the CGI Group, a Fairfax, Va., information technology services company, and used by the Environmental Protection Agency's Central Data Exchange to collect environmental information from states.

To build and manage FederalReporting.gov, the board issued a task order off an existing, competitively awarded EPA contract to CGI. The Recovery contract pays the firm \$9.2 million in fiscal 2009 and another \$9.7 million through the end of fiscal 2011, Pound said. A significant portion of those costs, he said, cover site maintenance and staffing for a help desk to assist registrants.

While board officials have suggested that using the site is no more difficult than shopping online, assistance is available through a toll-free support desk at 877-508-7386, by e-mail at [support@FederalReporting.gov](mailto:support@FederalReporting.gov), or via a live chat on the site's home page. The support desk currently is available from 7 a.m. to 9 p.m. Monday through Friday, but will operate around the clock during the initial reporting period in early October.

To sign up for FederalReporting.gov, registrants first must obtain a [\*DUNS business identification number\*](#). Grant and loan recipients also must sign up with the government's [\*Central Contractor Registration database\*](#) before filing a spending report.

On Aug. 13, the General Services Administration awarded a \$2.7 million sole-source task order to Dun and Bradstreet to support the data collection process and publication requirements. The fixed-price award was issued off an existing GSA multiple awards schedule contract, the [\*notice\*](#) stated.

The announcement said competition was restricted because "only one source is capable of responding due to the unique specialized nature of the work."

GSA did not respond to a request for comment about the task order.

Recipients must enroll at [FederalReporting.gov](http://FederalReporting.gov) before submitting spending reports -- due between Oct. 1 and Oct. 10 -- detailing almost 100 data elements, including how much money they have received, the amount they have spent so far, the timetable and scope of their projects, and the number of jobs created. Quarterly status reports will follow the first reports. Recipients can use a standardized XML or Microsoft Excel templates to fill out the reports.

The recipient data will be publicly available beginning on Oct. 11 at the revamped Recovery.gov Web site. The data will feed into maps, charts, downloadable data sets and other interactive features, according to the board.

The 28 federal agencies that have disbursed stimulus funds also must sign up at [FederalReporting.gov](http://FederalReporting.gov) to review information recipients submitted and discuss with them any errors or corrections. While the award agency can view the information, only recipients will be able to change the data once it is submitted, and only for a short period after the Oct. 10 reporting deadline.

The board will monitor any changes made to spending reports once they are submitted. Software will be applied to track and graph what changes are being made, in which categories and by whom.

The board expects 150,000 to 200,000 recipients to file reports by the Oct. 10 deadline. But Recovery Board Chairman Earl Devaney acknowledged during a recent interview with Government Executive that those figures are only a rough estimate.


