
AGA NEWSLETTER

AGA. IDAHO CENTENNIAL CHAPTER May Luncheon Recap!

Lt. Gov. Brad Little was our guest speaker who spoke about Leadership & shared some Idaho statistics and facts. Little touched on budget challenges that Idaho faces such as having twice as many roads as our neighboring states while also having a smaller population to carry



the cost of maintaining those roads. **Speaker Lt**. **Gov**. **Brad Little** — **Leadership!** He believes Idaho succeeds by being very fiscally conservative and avoiding weird tax accounting tricks to cope. This is shown through our 95% funded pension trust fund while similar states aren't as funded. Little reminded us that Idaho managed to recover from an 8.8% unemployment rate during the recession to around 3.4% today! He also emphasized that Idaho has one of the strongest GDPs, behind only gas & oil producing states. Little recommends focusing on education and bringing in more quality jobs, despite



already having a good unemployment rate. "Not be job takers, but job choosers." Little finished the luncheon with a question & answer session about ideas on how to improve accountability.

Minutes from previous meeting: Chris Stratton moved and Carol Bearce seconded the motion to approve the previous meeting's minutes with the correction of a typo. The motion passed.

Treasurer's Report: Joey Sanchez moved and Katie Curran seconded the motion to approve the Treasurer's Report. The motion passed. Minor expenses were discussed. PDC registrations were deposited and are a combination of credit card payments and State warrants. PDC revenues reflect the fees charged by RegOnline. Dues have been sent to AGA National.

President's Update: Judy Shock had everyone introduce themselves along with their place of employment and what Chapter position they hold or will hold. Judy has been selected to be the new Regional Vice-President. Chris Stratton and Katie Curran will be attending the Sectional Leadership Meeting in Kansas City.

President-Elect's Update: Chris Stratton reported that he contracted with Thrive to be the website manager/ developer for the next year and they are very responsive to requests for changes and updates. Chris requested that any needed updates be sent to him until Amy Dunaway becomes the new Communications Liaison in July.

Spring PDC: Lori Hendon and Marsi Woody reported that the contracts with hotel have been signed. We have 164 registrations paid attendees which is more than the approximately 150 last year. Still looking for volunteers to man the registration desk and coordinate the raffle.
