### A Discussion on Goodwill

I was recently asked if I would contribute something to the AGA newsletter. I quickly said sure and then just as quickly realized I needed to come up with a subject, specifically one that dealt with accounting. I thought I should discuss something that I had experienced professionally and was reasonably interesting so here is a discussion on goodwill; what you find interesting may differ greatly from what I find interesting.

So what is goodwill? Some of us may have learned this concept in class or had to recalculate it as part of an audit engagement or as part of mergers and acquisitions work. We may also be aware that the accounting treatment for this asset has changed over time.

In accounting, Goodwill is an intangible asset that can arise when a business is acquired by another business or partnership. Goodwill represents that portion of the business value that cannot be attributed to other identifiable assets, either tangible or intangible. For example, if a company's net market value is \$5M but the company is acquired for \$6M, that difference of \$1M is recorded as goodwill on the acquiring entity's balance sheet.

U.S. Generally Accepted Accounting Principles (GAAP) traditionally directed that goodwill was to be amortized for a maximum of 40 years. This meant that an entity would allocate the cost of the intangible asset over a period of time, similar to how a tangible asset is depreciated over a period of time. The result is that the company would expense a bit of this asset each year. Financial Accounting Standard (FAS) 142, "Goodwill and Other Intangible Assets" issued in 2001, removed that requirement and directed companies to value goodwill each year to determine if impairment is required i.e.

was the asset still worth the amount recorded in the books. For example, if the fair market value goes below historical cost (what goodwill was purchased for), an impairment is recorded to bring the value down to fair market.

When FAS 142 was issued, companies had to adopt the standard. Many accounting firms, including the one I worked for, assisted clients with the tests of intangible assets required by FAS 142. In some cases, companies had to record losses based on one-time adjustments due to goodwill impairment when they otherwise might have shown a profit for that same period of time. For other companies with intangible assets having indefinite lives that were not impaired, the adoption of this standard allowed them to retain the value of goodwill on their balance sheets.

There is a lot more information on goodwill and other intangible asset valuations but this is all the space I was allowed.

## CGFM Spotlight - Robin Faass, CGFM



The Chapter asked CGFM Robin Faas (CGI) and Olufunke Olusesi (DoS) questions to provide insight, ideas, and methods used to pass the CGFM exams. Congrats to both Robin and Olufunke on recently earning the CGFM designation!

### ***What first made you want your CGFM certification? Was it required?***

I saw an email about a newly-forming study group and decided I would try for the certification as a personal challenge/goal.

### ***How long did you study before taking the exam?***

I studied approximately 2 months for each of the three exams – several days per week for 2-3 hours. I also took advantage of the practice exams, which I would highly recommend to others pursuing the CGFM.

### ***Were you in a study group?***

I was in a study group for Book/Exam 1 and approached the other two exams in a self-study format. For the self-study, I scheduled the exam for two months out after receiving the study materials. This kept me disciplined in the time I allotted each week to study since I knew the exam was pending.

### ***Do you think a study group would have helped?***

The study group did help me by having a support group where together we could have questions answered and overcome any introductory fears about the exams and the certification process in general.

### ***How do you think CGFM has helped you in your profession?***

I have only been certified for a few months but it has helped me see the entire Government Financial picture more clearly and completely. For example, when the DOS Consolidated Financial Report was released early this year, I found the information enjoyable and enlightening since the CGFM study guides covered the CFR in detail. I am also more capable of understanding the budget and financial process within my own local government.

### ***To whom would you recommend the CGFM certification?***

Anyone who is involved or interested in learning more about the government financial world, at either the local or federal level .

## CGFM Spotlight (continued) - Olufunke Olusesi, CGFM

### ***What first made you want your CGFM certification? Was it required?***

When I joined AGA, Ms. Georgia Middleton, my prior manager and mentor encouraged me to take the exam. With the accountability from the aforementioned individuals, it certainly motivated me to take time to study the materials and subsequently pass the exams. Although the CGFM is not required for my role, I decided that earning the CGFM certification was a goal worthy accomplishment.

### ***How long did you study before taking the exam?***

The study length varied based on each section. For the 1st section, it took me about 3 days to prepare for the exam while the 3rd section took me a week of preparation. I took the 2nd portion of the CGFM last as it involved a higher volume of information and studied for a week. Unfortunately, I failed the 2nd exam as taking a week to study was clearly not a smart decision. I took about 3 weeks to prepare again for the 2nd section and passed.

### ***Were you in a study group?***

I was not in a study group.

### ***Do you think a study group would have helped?***

I prefer to study alone.

### ***How do you think CGFM has helped you in your profession?***

I do believe that being designated with the CGFM credential has elevated by career and I have to state that the course study material also provided some insight as to the governmental structure, government financial management functions, and the performance measurement and metrics from an OMB perspective.

### ***To whom would you recommend the CGFM certification?***

I would recommend the CGFM certification to everyone whether acting in Civil or Foreign Service capacity, or as a Locally Employed Staff, or as contractor or consultant within a governmental environment.
