





MEMBERSHIP DEMOGRAPHICS*


Member by Type

CITIZEN-CENTRIC REPORT (CCR)

With the enactment of Public Law 30-127, An Act Relative to Adopting the Association of Government Accountants' "Citizen-Centric Report" Initiative, CCRs are mandated by law to be completed by each government of Guam entity no later than sixty (60) calendar days after the independent audit report for a government entity has been released by the Guam Office of Public Accountability.

Furthermore, Title 1 Guam Code Annotated Chapter 19 §1922(a), every director, administrator, president, or head of a Government of Guam agency, including line agencies, autonomous and semi-autonomous agencies, public corporations, the Guam Mayors' Council, the Courts of the Judiciary of Guam and the Guam Legislature shall submit an annual Citizen-Centric Report: (1) via .pdf email attachment; (2) to the Public Auditor of Guam and the Speaker of the Guam Legislature; (3) no later than 60 calendar days after the release of the entity's independent audit report; and (4) to be posted on the entity's website.

Standards & Guidance - CCR

AGA National provides guidance on how to prepare a visually appealing CCR as well as some samples of completed CCRs.

Completed CCRs can be emailed to <u>ccr@agacgfm.org</u>, and a team will review and provide constructive feedback on ways to make your report more informative and meaningful. Additionally, AGA National recognizes well designed and informative CCRs with an AGA **Certificate of Excellence**.

RESEARCH AND STANDARDS UPDATES





In May 2020, <u>GASB issued Statement No. 95</u>, <u>Postponement of the Effective Dates of Certain Authoritative Guidance</u>, which postpones the effective dates of GASB Statements No. 84, 89, 90 and 91 by one year and GASB Statement No. 81 by 18 months; however, earlier application of the provisions addressed in GASB Statement No. 95 is encouraged and is permitted to the extent specified in each pronouncement as originally issued. Below are the affected pronouncements, which we also covered during our GASB training in March:

- GASB Statement No. 84, Fiduciary Activities
- GASB Statement No. 89, Accounting for Interest Cost Incurred before the End of a Construction Period
- GASB Statement No. 90, Majority Equity Interests an amendment of GASB Statements No. 14 and 61
- GASB Statement No. 91, Conduit Debt Obligations
- GASB Statement No. 81, Leases

Additionally, the Office of Management and Budget issued Memorandum M-20-17 providing short-term relief for administrative, financial management, and audit requirements under 2 CFR Part 200, including, among others, the 6-month postponement of the Single Audit reporting deadline.

GASB has the following documents for public comment:

• GASB Proposes Concepts for Recognition of Financial Statement Elements

Last June 30, 2020 – GASB released a Concepts Statement covering concepts for recognition of assets, liabilities, and other elements of state and local government financial statements. The Exposure Draft, Recognition of Elements of Financial Statements, aims to establish consistent accounting and financial reporting principles for recognition of elements in financial statements.

GASB Requests Input on Revenue and Expense Recognition Proposals

Last June 30, 2020 - The Board asked its stakeholders to review and provide input on its proposal on a new revenue and expense recognition model. The proposal intends to:

- · Develop guidance applicable to topics for which existing guidance is limited,
- · Improve existing guidance that has been identified as challenging to apply,
- · Consider inclusion of a performance obligation approach in the GASB's authoritative literature, and
- · Assess existing and proposed guidance based on the conceptual framework.

Lastly, GASB released Accounting and Financial Reporting Guidance Related to the CARES Act and Coronavirus Diseases

Last July 2, 2020 – GASB issued a Technical Bulletin which contains guidance for applying existing standards to transactions related to the Coronavirus Aid, Relief and Economic Security Act (CARES Act). It also details a guide for certain outflows incurred in response to the pandemic. This is part of the group's efforts in assisting state and local governments during the COVID-19 pandemic.

- 3. Must have demonstrated the skills to be an outstanding leader and has shown a commitment to improving government operations.





