Professional Certification

The Certified Government Financial Manager (CGFM) certification acknowledges the specialized skills essential for today's government financial managers. To earn this certification, candidates must pass three comprehensive exams: 1-Government Environment; 2-Governmental Accounting & Financial, Reporting and Budgeting; and 3-Government Financial Management and Control.

AGACA CGFM Scholarship Opportunity:

The AGA Central Arkansas Chapter is excited to offer two \$240 CGFM scholarships to assist with examination fees and preparation materials. These scholarships will help cover part of the CGFM application and examination costs. Each fiscal year, a maximum of two scholarships will be awarded.

Deadline:

Scholarships will be granted to the first two qualified applicants who pass their exams. Incomplete applications will not be considered. Applications must be received by May 31.

Qualifications:

- Must be an active Central Arkansas AGA member in good standing
- Must be employed as a governmental employee local or state
- Must pass all three parts of the exam before applying
- The applicant must pay exam and application fees

Awards:

Winners will be notified via email and will receive their checks at the annual AGA Central Arkansas Awards ceremony in June.

How do you become a CGFM?

To earn the CGFM, you must fill out an online application (<u>https://www.agacgfm.org/CGFM.aspx</u>) and meet the following requirements:

Ethics - read and agree to abide by AGA's Code of Ethics

Education – have a bachelor's degree in any subject area from an accredited U.S. college or university

Examinations - pass three comprehensive CGFM examinations

Experience — have at least two years of professional-level experience in government financial management


