"The Actions Necessary to Keep a Clean Audit Opinion"

**Hazel Broadnax, Deputy Director of Financial
Operations, Pension Benefit
Guaranty Corporation**

Hazel Broadnax is presently the Deputy Director of Financial Operations for the Pension Benefit Guaranty Corporation where she administers financial systems and operations, policies and procedures, financial reporting, collection and compliance of pension plan filings and serves as the primary assistant to the Director and Chief Financial Officer.

PBGC is a federal corporation created under the Employee Retirement Income Security Act of 1974 to guarantee payment of basic pension benefits earned by nearly 42 million American workers and retirees participating in 55,000 private sector defined benefit pension plans. The agency receives no funds from general tax revenues. Operations are financed largely by insurance premiums paid by companies that sponsor pension plans and investment returns.

Before coming to the federal government, from 1981 until 1993 she worked in various jobs for the District of Columbia, including serving as the Controller of the Department of Human Services. Her responsibilities as Controller included overseeing and administering financial management of a \$1.4 billion dollar budget, fiscal accounting, resource allocation, the Medicaid program, and payments and collections of the entitlement programs. She also served as the manager of Grants and Audits for the District Government under the D.C. Controller.

Prior to joining the District Government, she was the Executive Director of a nonprofit organization which was federally and locally funded. Her affiliations include membership in the American Institute of Certified Public Accountants; the D.C. Institute of CPA's; and the Government Finance Officers Association. In the GFOA she is Chair of the Membership Committee for the Washington metropolitan area. For the DCICPA she serves on the Financial Institution Committee.

Summary of Luncheon Speaker's Remarks: Defense CFO Shares Personal Insight to Recent Elections

One of the great advantages of membership in the Washington Chapter of the AGA is the opportunity to hear key individuals from both government and the private sector speak about diverse topics and issues that affect us personally and professionally. November's luncheon was no exception when the Under Secretary of Defense (Comptroller) and Chief Financial Officer, Dr. John Hamre, addressed a large audience on his views on the recent presidential and congressional elections. Dr. Hamre initially surprised the audience by saying that he would not talk specifically about financial management in the Department of Defense, the scheduled topic. Rather, given that our luncheon was held a mere 48 hours after the election, he chose to share some his personal insight as to what was going through his mind immediately following the reelection of President Clinton as well as elections in the House and Senate. Further, he examined the wake of the election to project the effects it will likely have on those of us in the government, as well as the direction for which the government and the country seem to be heading.

Perhaps the most striking aspect of the election was uniformity. Overall, there was very little change in the composition of elected officials. "It strikes me that this election, in many ways, was like a comma in a very long sentence," said Dr. Hamre. "It doesn't serve anything but to pause, catch your breath, and keep going." Only one member of Congress who ran for a state-wide office was not reelected. Similarly, of the 122 members of Congress who sit on oversight committees for the Department of Defense -- Armed Services, Intelligence, and Appropriations -- only one was defeated. "This was an election of incumbency," Dr. Hamre added. "Part of it is, the power of incumbency. More than that, it probably is a message of where America is right now." In more tangible terms, the election signaled that America was perhaps not ready for significant change. That Americans are generally comfortable with the direction the country is heading. All of this stands in stark contrast to the elections of two years ago when a new Congress was installed by a boisterous public ready for change -- referring, of course, to the new Republican-controlled Congress.

Foremost of the election, Dr. Hamre said he was surprised by aspects that appear to be anomalies. Four years ago, when independent presidential candidate Ross Perot dominated the intellectual content of election, balanced budgets became the forefront of the political debate. Similarly, during the 104th Congress, if there was one event which shaped the entire two years, it was the balanced budget amendment and the way it passed in the House and nearly passed in the Senate. The balanced budget became the centerpiece of American politics -- it was just assumed that we were going to have a balanced budget in this election. But how was it going to be achieved? How could Bob Dole balance the budget and cut taxes at the same time? How could Bill Clinton continue with the many programs he has championed and balance the budget? These questions very much dominated the debate about who was best qualified to lead the country into the 21st Century.

What's clear about this election is that the American public voted overwhelmingly for a President with one view of government and a Congress with a very different view. Again, this stands in stark contrast to the elections of two years ago when a new political ideology created a new debate about the role and direction of government. The last time we had faced a debate of this magnitude was in the 1930's, when Franklin D. Roosevelt defeated Herbert Hoover and set a new path which dominated government for the next sixty years. What we are facing now, is similar to that time period.

What's emerged from this election is a climate of political conciliation. Both sides have clearly defined the issues for which they will not give up. The Republicans, for example, know they cannot touch Medicaid. Similarly, the Democrats know they cannot raise taxes. Yet, again, we are facing an American public set on a "zero deficit" policy. We are in a political stalemate and the fundamental question is: Are we in a new era of government? Are we in a post-FDR type of government set on dismantling the liberal infrastructure? We

have therefore created a new debate about the future of our government and most important, what role the government will play for the next several decades.

This new debate was distinguished, however, by a flawed political strategy, referring to last year's shutdown of the government. It proved to be disastrous for the new Congress. The shutdown did many things to government and the way in which the American people perceive it. "It's amazing how our electoral process forces us back to our basic principles, like what does it take to get elected," said Dr. Hamre, referring to the political conciliation and uniformity evident in this year's election.

Unlike most federal agencies, the Department of Defense has enjoyed a relatively protected status over the last couple of years. The reason for this protection was, primarily, a republican controlled congress that wanted to re-create the excitement of the Reagan era with a powerful national defense. But it didn't catch on with the American people. Most people these days are more concerned with issues that affect them directly -- in their own communities -- more than overseas conflicts such as Bosnia and Haiti. Americans are more concerned about their children's schools, drugs and violence, to name a few examples. At the same time, other agencies are taking significant cuts that will severely impact their ability to serve the public. Some agencies are looking at reductions of operating costs up to 42% over the next five years -- a

staggering figure. But how are they going to achieve reductions of this size? No one really knows for sure and this creates unusual pressures for financial managers. Financial managers have to engineer real solutions to these problems, and they face some very tough issues over the next couple of years.

Dr. Hamre further emphasized that we are in a very critical period in government. Until we are able to bring all pieces of the debate to the table -- entitlements, taxes and discretionary spending -- and engineer real solutions, we will continue to remain in a critical state. What we are facing as financial managers is equally critical. "I think there is one thing that everyone in government is going to be facing. The government is just going to stop doing some things," Dr. Hamre expressed his personal concern over. He added that there are still many vital functions that only the government can and must perform to insure the safety of the public -- that the aircraft we fly on and the buildings we work and live in have met certain standards, for example. Too many cuts are somewhat irresponsible. The proposal to do away with the Internal Revenue Service, for example is irresponsible. We have remarkable tax compliance

in this nation compared to other countries. We need to insure the financial security of our government and the nation as a whole. Dr. Hamre also thanked Vice President Gore for having launched the National Performance Review (NPR). Most important, the NPR made a realistic attempt to make the core of government more efficient. The NPR accommodates an American public eager for both a smaller and more efficient government, yet one that meets their expectations. Perhaps one of the most

important results of the NPR is that it invigorated government employees in the field and, in turn, reversed the negative perception of government employees by the American people. On the surface this election won't change anything. Below the surface, it will truly set a new path for our government and our country.

Volunteer Income Tax Assistance (VITA)

Do you want to help people prepare their federal and state income tax returns during the upcoming tax filing season? Are you an accountant or CPA? If so, the VITA program at the Martin Luther King Memorial Library (MLK Library) wants you.

VITA stands for Volunteer Income Tax Assistance. VITA volunteers prepare tax returns for people with income of \$30,000 or less. The VITA program has operated for years at the MLK Library at 901 G Street, NW. The library is conveniently accessible to Metro at either the Metro Center or Gallery Place stations. The library also offers free parking in its underground parking garage.

The VITA program will start Thursday, January 23, 1997, and will run through April 16, 1997. VITA volunteers prepare federal and state (DC, Virginia, and Maryland) tax returns on Tuesday, Wednesday, and Thursday evenings from 4:30 p.m. until the library closes. On Wednesdays and Thursdays the library closes at 7:00 p.m., and closes at 9:00 p.m. on Tuesdays. On Saturday we offer tax preparation help from 10:00 a.m. to 5:00 p.m. and on Sundays from 1:00 p.m. to 4:30 p.m. There will be additional Monday hours during April.

If this sounds like something you want to do, mark your calendar so you can attend a tax refresher class at the library in Room A-9, Saturday, January 4, 1997, from 10:15 a.m. to 5:00 p.m. and let the VITA coordinator you plan to attend.

When you help people prepare their income tax returns you provide a valuable civic service that you will find personally rewarding. If you are interested, first consider your calendar from January 23 to April 16. Because there are never enough volunteers, we ask each volunteer to commit to helping one day each week during the 1997 tax filing season. On Saturdays, a volunteer needs to commit to only four hours. Review your calendar now and mark the day you want to volunteer and make it a standing appointment you won't break. Volunteer scheduling is flexible and we understand that emergencies and other important, unexpected situations arise. In those situations all we ask is that you contact the VITA coordinator.
