Member Spotlight — Michael Winston, CGFM

My name is Michael Winston, and I am currently serving as the Nashville Chapter President-Elect. That means I have the honor and privilege of leading this great chapter during the 2018 – 2019 program year. As I think back on my journey to get here, it's surprising that I made it to Nashville, let alone that I made it to AGA. But I am so fortunate that I did make it here, and I am looking forward to where the Nashville Chapter and I are going next.

While I was born in Florida, I grew up in Knoxville and will always think of it as my home. I grew up surrounded by an extended family that got together at church twice a week and many birthdays, holidays, and family dinners in -between. My great-grandmother always saved a seat for me next to her on the church pew and on the couch when the Atlanta Braves were playing. It was my close relationship with her where I discovered a love for jigsaw puzzles, card games, and crossword puzzles. It was the crossword puzzles that laid the foundation for my love of the newspaper. While I used to skip straight for the comics and puzzles page in the News Sentinel, I slowly started checking out the news in the other sections. I discovered a passion for reading, especially about current events locally and around the world.

In school, I did well for many years, but subjects got harder in high school, and I wasn't as interested in getting straight A's as I used to be. That is until I walked into Ms. Davis' Beginning Accounting class. To this day, I am so lucky that West High School offered an elective on accounting. Debits and credits made so much sense to me. A fellow student and I used to race each other in class to see who could get our assignments done first. Truth be told, he would usually beat me on turning it in, but I was more accurate in getting the correct answers. From then on, I knew I was going to major in accounting when I got to college. And true to form, I stayed in Knoxville and got my bachelors degree in business administration from the University of Tennessee.

While I was in college, I had the opportunity to start working for a local credit union. I started out as a teller and moved on to new accounts and even lending. Not only was it good professional experience, but I also learned a lot about internal controls and compliance with regulations — skills that I didn't know I was really going to need down the road. Towards the end of my five years with the credit union, I graduated from UT and moved into a full time position in loss prevention. While I was fortunate to have a full time job when many of my classmates were struggling to find positions during the recession, I was not enjoying what basically amounted to collections work.

Over the next few months, I searched and searched for a new job opportunity. My main goal was to find something that would let me really use my accounting degree. When the big job search sites didn't seem to be providing a lot of options, I realized that I hadn't looked at government positions. So I found my way to the State of Tennessee website and started filling out an application. I got to the question that wanted to know what counties I would be interested in working in, and that was the first time I truly considered leaving Knoxville to work somewhere else. To make an already long story a little shorter, I landed in Internal Audit with the Department of General Services here in Nashville.

My experience with the State has been nothing short of fantastic. It has been the perfect intersection between my educational and personal interests. I get to help craft budgets and financial management strategies in the government environment that is reported in the news daily. Not that I ever want to see my name in the news, but it is very rewarding to see how my work affects the citizens of Tennessee. Looking back, it seems so obvious

that I would enjoy a career in government, but yet it took me a long time to find it. So I have to attribute this to a lack of awareness about career opportunities in government, and I think that is where AGA comes in.
