
### AGA Seattle Chapter Summary of November Training Event

On November 12th, the AGA Seattle Chapter hosted our November training event and had the pleasure of welcoming Kate Reynolds, Executive Director of the Washington State Executive Ethics Board, to discuss ethics in the public services sector. Kate gave an informative overview of the Executive Ethics Board – who they are, what they do, and how they fit into the larger structure of the Washington State Government. She also provided some great (and humorous!) examples of investigations her office has been involved with and what often sparks these investigations. We had a robust discussion on what defines conflict of interest for public service employees and how her office helps state employees manage those conflicts so they don't end up in sticky situations. Did you know that some state employees are categorized as "section 4" employees and that they can't accept flowers from persons or agencies they contract with or may contract with? If you are a state employee, you probably already knew that, given that Kate's office offers classroom trainings to state agencies and their website contains online trainings and other materials. Kate's presentation really highlighted the fine lines of ethics we all walk as stewards of public resources.


## Chapter Awards Ceremony
