

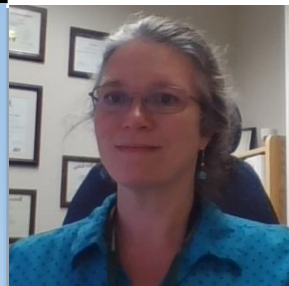

March was CGFM month. What is CGFM? The acronym stands for Certified Government Financial Manager.

Many who have attended our events know how excited we are about this certification. This is not an easy certification to obtain, but it is well worth it. In the certification process, candidates learn about the Governmental Environment, Governmental Accounting, Financial Reporting, Budgeting and Governmental Financial Management Control.

This certification gives people who may not be familiar with governmental financial management a comprehensive overview of how the different components work for federal, state, and local government. For those who have worked in government for a while, it can help fill gaps one may have in their understanding and help them understand how everything works together. Have you ever wondered why something is done a certain way, or what happens before or after you do your process? In many cases, studying for the CGFM can help build that understanding.

Our chapter continues to provide our members with resources to help pass the CGFM. We facilitate study groups for the three different exam sections, which are lead by a CGFM. If you prefer self study, we also have a lending library which allows you to borrow a study guide so you can study on your own at your own pace. We also reimburse members who pay out of pocket (and are not reimbursed by their agency) once they successfully pass the exam.

As an added bonus, some people may get a raise for becoming a CGFM! The CGFM is listed as one of the approved Certifications under the Pay Plan Policy for Professional Skills/Competency Development. It is approved for up to 5%!

#### **Question: Why did you want to facilitate a CGFM Study Group**



#### **Response from Heather N. Gillenwater, CGFM, who facilitates the study group for Book 1: Government Environment:**

I was trying to self-study for the CPA as well. I had almost talked myself out of it, however my final deciding factor was when I attended the first study group meeting, I saw how excited the two organizing the group were about the material, so I figured, not only does the study material sound interesting, but being relatively new to state government, this credential could only benefit my career. Where some of the CGFM material is also material covered on the CPA exam, I figured it would help reinforce my self-study. I eventually talked myself into it & decided it was a win-win situation.

The classes started, it seemed like a lot of material, however I liked all the sections of the exam. Every section kept me intrigued & all were applicable to what I do on the daily, so I felt that I could apply my working knowledge to my studying and vice versa! Having that weekly accountability of a study group, that set schedule of material to complete, followed up by reinforcing the self-study with a weekly review of the material, was a large contributing factor in me passing the exam. Earning the CGFM designation is one of my proudest accomplishments. Throughout my time as an accounting student, I learned very little about accounting and auditing for government entities. A year ago, I was informed about a CGFM study group and joining was one of the best decisions I could have made for my career. The knowledge I have obtained from the CGFM has given me the confidence and skillset to further advance in my career.

Being out of school for five years, I was nervous about studying and taking the exams, but my experience couldn't have been better. AGA has easy to follow study guides full of reference material and practice questions.
