Purpose and Overview

Each year, AGA presents a maximum of two crystal awards to state government professionals who exemplify and promote excellence in government financial management and who have demonstrated outstanding leadership in enhancing sound financial management legislation, regulations, practices, policies and systems.

The award recognizes the outstanding leadership of individuals in state government that led to improved financial management practices, policies, systems or operations and consistently exhibited the highest personal and professional standards.

The nominee must have served in a state government position at the time of the recognized contribution.

Nominees do not have to be members of AGA. AGA chapters, individuals or government units may make nominations. An AGA chapter may only nominate one individual.

The award is presented by AGA at its Annual National Leadership Training (NLT).
