As my time as the AGA St Louis Chapter President comes to a close I want to thank the many board members, sponsors, members, and joint chapter members in helping us have a successful year.

Here are just a few highlights of our 2021-2022 year:

- AGA ST Louis took home the Gold Chapter Award!!! Thank you Peggy Javery for accepting and representing us at the AGA National PDT.
- Toni Swedlund received the AGA St Louis Chapter Voluntary Award and was recognized at the AGA National PDT for her achievements.
- Membership has gone up over prior year 15%.
- New student membership up with 5 new students.
- Renewal of members increased over prior year.
- Members participated in 10 surveys conducted after Lunch, Learn and Earn (LLE) and Professional Development Training (PDT) events. Results of the survey note an increase in the willingness to participate and value in the programs we were able to offer such as:
 - Joint functions with other government financial chapters increasing opportunities to network and learn.
 - New sponsor to support future PDTs and other activities (Deloitte).
 - Held 2 quarterly CPEs LLE's. Saw an increase from 20 people to 85 people participating.
 - Held the first AGA St Louis Chapter PDT in person and virtual event with 197 participants and 30 sponsors in which we were able to secure additional funds for the Chapter to support 2022-2023.
 - First year to have an outside of USDA Vice President, Jeremiah Hathorn broadening our reach into the private sector to invite private industry and have additional members. participate and join.
 - Social Media increased posting across several platforms bring awareness of government job opportunities, insights to what is planned, scholarship offerings, and a focus on Spot Light members.
 - New Letters provided volunteer remote opportunities allowing members to participate as they saw fitting to their safety and time.
 - CGFM training with two teams to support peoples schedule while continuing to seek their certifications.

Hispanic Heritage Month Fun Facts:

- 1. National Hispanic Heritage Month is celebrated from September 15 to October 15
- 2. National Hispanic Heritage Month celebrates the histories, cultures and contributions of American citizens whose ancestors came from Spain, Mexico, the Caribbean and Central and South America
- 3. The observation started in 1968 as Hispanic Heritage Week under President Lyndon Johnson
- 4. It was expanded by President Ronald Reagan in 1988 to cover a 30-day period
- 5. It was enacted into law on August 17, 1988
- 6. The day of September 15 is significant because it is the anniversary of independence for Latin American countries Costa Rica, El Salvador, Guatemala, Honduras and Nicaragua
- 7. In addition, Mexico and Chile celebrate their independence days on September 16 and September 18, respectively
- 8. Also, Columbus Day or Día de la Raza, which is October 12, falls within this 30-day period
- 9. The Law Library of Congress has compiled guides to commemorative observations, including a comprehensive inventory of the Public Laws, Presidential Proclamations and congressional resolutions related to National Hispanic Heritage Month
