Happy Holidays from all of us here at the AGA Nashville Chapter! The holidays are a special time to spend with family and friends and savor the good cheer of the season. It is also a chance for many of us to have a couple of days off of work to rest and recharge before the new year starts! As I think about 2019, there are a lot of potential changes coming our way – our Federal workers will have a split Congress in January, our State workers will see a new administration under Governor-Elect Lee, and even our Metro Nashville personnel will have mayoral and metro council elections in 2019! While it is tough to say how those leadership changes will affect us, we can be more certain about exciting changes and trends in our profession! I came across a new article on G2Crowd.com by Michael Gigante titled "30+ Important Accounting Statistics You Need to Know in 2019." Mr. Gigante has rounded up some important trends on the horizon for those of us who work in accounting, auditing, and other financial management areas.

For several years now, "the cloud" has been a popular term – generally meaning software or information accessed on a network rather than stored on a local device. According to Mr. Gigante's sources, "58% of large companies use cloud accounting" (Accounting Today) and "cloud computing reduces labor costs by 50%" (Forbes). Where does your government entity sit in terms of using the cloud? Chances are, your entity is already using the cloud in some form or fashion, but you can expect more and more of it in 2019. As a user, you may not notice much difference using a program in your internet browser as opposed to a desktop client, but it takes some getting used to and makes network outages all the more problematic. The cloud should also make us think twice about the security and confidentiality of the data we handle.

Another exciting, but potentially frightening topic is accounting automation. While it could make some of our jobs easier, it can also bring along the fear of jobs becoming obsolete. As Mr. Gigante found, "accounts payable professionals who automate invoice capture and payments save an average of one hour per day" (Vanguard Systems AP), and it can save \$16 per invoice depending on your entity's overhead and processing efficiency (MineralTree). While these time and money savings are significant, they shouldn't scare you. As workloads increase, automation will allow us to keep up with stakeholder demands to process more invoices at the same or quicker speeds.

### Member Spotlight Susan Slaton



When I graduated high school, I thought I had things mapped out and knew exactly where I was going. If that were the case, I would be a high school math teacher and softball coach. I had a love for mathematics and found joy in helping my classmates understand what we were learning. I remember, and will never live down, my mother mentioned that I ought to consider accounting – her logic at the time was that I liked numbers. What I liked was logic and processes. It's a wonderful thing that life changes and evolves and can take you on adventures you never imagined.

I was born a coal miner's daughter...but no where near Butcher Holler. I grew up on the family farm in Hopkins County, Kentucky. I claim to this day that I retired from farm-

ing when I turned 18 and went off to college, but my younger brothers and father would like to think otherwise. I attended Centre College for two years – where I regularly had to build web pages for projects. Then I joined the United States Army Reserves, moved closer to home, and attended Murray State University for a semester before I was called up to spend a year in support of Operation Iraqi Freedom. I was a Quartermaster and Chemical Equipment Repairer – which is a long way of say an "everything else" mechanic. They can't train you in a few weeks to know how to troubleshoot and diagnose all the different pumps, small engines, water purification systems, and laundry equipment (just to name a few). Instead, they choose people that can be trained to analyze a situation, determine what should be working, and figure out how to solve the problem. I'm sure that process sounds very similar to what many of us do as government accountability professionals.

While I am proud to have served, I never intended for the Army to be a full-time career and it seemed to interfere with completing my education at the time. I decided that once my service was over, I would return to school, following behind my little brother at Western Kentucky University. This time, instead of mathematics, I chose accounting and found my love for logic and processes in a whole new world. Yes, I did tell my mother she was right about accounting – it only took me ten years to make the connection. While in Bowling Green, I applied my accounting skills to help with the very active Veterans of Foreign Wars chapter – serving as Quartermaster for two years at both the post and district level. The Quartermaster is the financial officer for the post and responsible for all books, records, and reporting items.

In February of this coming year, I will have been with the Tennessee Comptroller of the Treasury's office for five years as an information systems auditor. I joined the Nashville Chapter of AGA not long after starting with the office and have been part of the education committee. I currently serve as a twoyear director and webmaster co-chair. I enjoy being an active part of AGA and being a part of improving accountability for Tennessee and its citizens.
