
**Jose Arrieta,**

Jose Arrieta is the Associate Deputy Assistant Secretary for Acquisition for the US Health & Human Services (HHS), Arrieta is bringing his work with emerging technologies, more specifically blockchain, the proven benefits of its foundational proponents and the power of accurate data to public procurement and the federal health sphere. 

On May 2, 2018, the Mentorship Committee sponsored a 2 hour Lunch and Learn Leadership program highlighting “The Science Behind Effective Teams” where 23 chapter members actively participated. This interactive program highlighted how Chemistry can serve as a basis for understanding team development and performance, or lack thereof. For this reason, people often use the word “chemistry” to describe an intangible, but positive effect on team performance.

## ***Inside The Black Box***

### Background

The general ledger account listing by the U.S. Standard General Ledger (USSGL) includes a designation of a normal debit or credit balance for each account that has been in use for over a decade. However, sometimes an agency has to back out activity, which could result in an abnormal balance.

### Spending Adjustments - Disbursed

Back before 1990, only one USSGL account was used for obligations (4800) and another for expenditures (4900). Then Treasury wanted to track cash through the budgetary accounts, replacing the last zero with one for unpaid and two for paid; and OMB wanted to separate out deobligations and refunds from increases in spending from prior-year obligations, which changed the penultimate zero to seven for downward adjustments and eight for upward. So now this same activity is tracked through twelve USSGL accounts (plus an additional three for transfers, but I'm going to ignore those for this discussion). Suppose an agency receives a refund of monies disbursed in a prior year. Is that a downward adjustment (also referred to as a recovery)? The USSGL Transaction List shows debits to 497200 Downward Adjustments of Prior-Year Paid Delivered Orders - Obligations, Refunds Collected in entries such as C132 and C136, but these always credit available or unavailable funding such as 445000 Unapportioned Authority or 465000 Allotments - Expired Authority. On the Statement of Budgetary Resources (SBR), disbursements posted to 490200 Delivered Orders - Obligations, Paid show up in Section 2 Status of Budgetary Resources as new activity on line 2190, but collections posted to 497200 show up in Section 1 Budgetary Resources as an adjustment on line 1043. The reason downward adjustments show up in Section 1 alongside new appropriations is that OMB wants to apportion the funds, and can prevent an agency from immediately spending them by withholding the apportionment.

However, suppose the refund occurred while the contract is still live. Perhaps it was a refund of an overpayment with no impact on the total contract amount. In that case, the budgetary posting would back out B107 with a debit to 490200 and a credit to 480100 Undelivered Orders - Obligations, Unpaid. Since both those accounts are mapped to SBR line 2190, this entry has no impact on the top section of the SBR. OMB can't apportion the funds because they are not available; they have already been obligated.

The problem with backing out B107 is that it posts an abnormal debit in 490200. If the fund has a lot of normal activity, this debit will be overpowered by credits, and the trial balance for that symbol (TAS) will still show a normal credit balance. But if there isn't much activity against that TAS, or if the refund is for a very large amount, or occurs at the beginning of the year, then the trial balance will show an abnormal debit balance and could also cause SBR lines 3020 and 4185 Gross Outlays to go negative. Many auditors would see these as red flags for improper activity.

But what are the alternative treatments? Moving the debit entry or balance of 490200 to 497200 would show it as normal, but it would record a downward adjustment to obligations in SBR section 1 when there was none, and imply these are new funds that must be apportioned when they are already obligated. Offsetting the 497200 entry with 488100 Upward Adjustments of Prior-Year Undelivered Orders - Obligations, Unpaid wouldn't help, since 488100 appears in section

## ***Inside The Black Box (Cont.)***

I consider a credit balance in 487100 unsupportable, since it is specifically designed to gather downward adjustment debits. Account 490200, on the other hand, is used in many different types of activity. The USSGL Transaction Listing even shows debit entries to 490200 in entries C134 and C138 Refunds Collected, although those are supposed to be used for current-year activity. I think the main problem with 490200 is that it is a temporal account which begins each year with a zero balance. While it should be unacceptable for an asset to have a credit balance or a liability a debit balance, accounts which track annual activity can have negative balances.

### **Spending Adjustments - Obligated**

This means that disbursements can go negative but obligations can't. Or can they? Back when there was only account 4800, it would never hold a debit balance because it was a permanent account. When the account was split into 4802 for orders with advances and 4801 for those without, it still shouldn't go negative because (1) advance applications shouldn't ever exceed advances paid and (2) advances issued should never exceed the balance of the obligations supporting them. The key here is that both 4801 and 4802 were permanent accounts. However, now that we have upward and downward adjustment accounts, it is possible for a fund to have significant upward adjustments entered in 488100 that are liquidated the same year in 480100, causing 480100 to have a debit balance. So when looking to see if balances are normal, one has to sum 480100, 487100 and 488100 for unpaid and 480200, 487200 and 488200 for paid undelivered orders, i.e., look at the pro forma post-close balances.

### **Red Flags**

Just as there are good reasons for abnormal balances, there are also bad ones. Abnormal balances should be treated as a red flag that calls for investigation, but not something wrong *per se*. For debit balances of 490200, these should be caused by refunds against legitimate contracts that are still open. If an agency creates a catchall order to prevent funding from expiring at year end and increases its open balance by assigning various collections against it, then that is a problem. However, the catchall obligation is a concern even if it doesn't result in abnormal balances. It could be considered an attempt to thwart the will of Congress or OMB. Similarly, if the debit balance in 490200 is caused by large accruals of disbursements that are reversed in the new year and not offset by reconciled disbursements soon, that is an indication that the agency is not reconciling their fund balance with Treasury in a timely manner.

### **Conclusion**

Abnormal balances are a serious problem for permanent accounts, but are only an indication there may be a problem for temporal USSGL accounts (or permanent accounts whose activity is partially recorded in temporal accounts). The USSGL Board needs to address situations where abnormal balances are valid, for example, adding a transaction where a refund is re-obligated in a prior-year fund. If the USSGL Board wants to make abnormal balances an error, then new accounts are needed to hold transactions that can cause abnormal balances, such as an alternate 4902 for


