### POST SPRING 2020 PDT MEETING MINUTES

## April 30, 2020 12:00pm

- o President Thank you
- Treasurer recap
  - No. Registrations 75
  - No. Member 67
  - No. Non-member 8
  - Revenue Expense Summary Current NET is \$2,898.19. We are still awaiting 1 outstanding check payment, and we have expenditure reimbursements of \$200.00 which still need to be paid.
  - Outstanding Collections There is 1 check we are still waiting for.
  - We will be reaching out to the 8 non-AGA members providing them information related to membership.
- o Community Service Chair Recap
  - Raffle Summary Went very well; people liked the online platform.
  - Funds raised \$770.00 TOTAL including match from AGA.
  - Status of drawings Each winner has been notified; the gift cards have been distributed.
  - Thank you notes and gift cards for each speaker have been distributed.
  - There were \$100.00 in expenditures for both the raffle prizes and the speaker expenditures (\$200.00 total).
  - 19 people donated to the raffle fund raiser.
- o Education
  - Evaluations people seemed to like the on-line platform.
  - CPEs these will be distributed no later than May 8 giving participants time to submit the evaluation forms.

- Lessons Learned
  - UNRELIABLE INTERNET ACCESS The organizer should be managing the presentation files (and not the presenter) to avoid technical problems. Possibly use the phone instead of the computer as the voice audio has no delay.
  - ANNOUNCEMENTS SHOULD BE REPEATED We should repeat the announcements intermittently throughout the conference and not just at the opening.
  - POSITIONING OF LETTERS We should insert the letters ourselves after the speakers have submitted their presentations in order to achieve consistency.
  - PROGRAM DISTRIBUTION Getting the program out sooner before the start of the conference would help. Some items, such as sponsors, can be updated later.
  - ON-LINE RAFFLE We seemed to be able to raise more funds on-line due to the convenience. This is something we should consider repeating. We should also set a higher goal for next time since we had such a positive response.
  - SPEAKER PRACTICE The "run thru" for the speakers before the conference was very helpful to avoid major glitches with technology during the presentation.
  - LUNCH BREAK Some participants requested a lunch break, but we do not feel this is necessary unless we conduct a full day session.
  - STATE & LOCAL TOPCIS We feel that these topics (which was the focus of our conference) are well suited to our audience currently.
  - LOWER PRICE We feel that the "on-line" lower price contributed to the large turnout and participation.
  - AGA TO INVEST IN PLATFORM? We felt that the on-line format worked so well that it would be worthwhile for AGA National to consider investing in a similar presentation platform for all the chapters to use. This is something that can be explored next year with AGA National.
  - REGISTRATION FEATURE "Go to Webinar" has a built-in registration feature which we may want to consider using in the future if the price is reasonable/low/free.
- May end of year Celebration This is on hold for now due to Corona Virus.
- Josh to distribute summary evaluation results to the board members.
- We are working to complete the Board for the 2020 2021 year.
