





Background: I work on the Financial Report of the United States Government which Treasury issues in

conjunction with OMB. We use the agencies' financial statements to compile the governmentwide financial statements so I work closely with many people at the agencies and with OMB and GAO as we work to resolve audit issues. Before coming to Treasury, I worked at HHS and was the audit team leader when HHS got their first clean audit opinion. Prior to that, I was with the CPA firm Laventhol & Horwarth for five years, which was my first job in accounting after changing careers. I was a biology major in college and spent the first eight years of my career as a microbiologist doing recombinant DNA work such as cloning.

How long have you been a member of AGA? Since 1997. I was Treasurer of the DC Chapter in 2003 and 2004.

How has AGA helped you with your career?



Asset Disposals for Replacement

Introduction

When an agency sells property with the intention of using the proceeds to supplement the purchase of replacement property, the agency can normally keep the funding

for one year (sometimes two years). There are two different posting streams based on whether the sale is before or after the replacement property is purchased.

Purchase Precedes Sale

When an agency sells property after the replacement has been ordered or purchased, only one entry is required. The basic entry is to clear out the asset and associated accumulated depreciation accounts, debit Fund Balance for the cash deposited, and record any difference as a gain or loss. Also the budget is augmented with a reimbursement entry, which would normally debit Other Actual Collections (account 4266 from non-federal sources and 4277 from federal) and credit funding status (4450 if not yet apportioned, 4620 if not subject to apportionment, or 4060 or 4070 if the anticipated sale had been included as a budgetary resource). In addition, if the fund is appropriated, then it will be necessary to back out the use of appropriations to buy the replacement. The USSGL guidance pairs this last entry with the purchase transaction, but it is easiest to record it simultaneously with the sale. As an example, if an agency sells office equipment to a local government for \$50,000 that had been purchased in an appropriated fund for \$250,000 with \$180,000 depreciated, and the sale proceeds were not yet apportioned, the entry would be:

Sale Precedes Purchase

When an agency sells property before the replacement has been ordered or purchased, the proceeds are deposited in a special deposit fund F3845 Proceeds of Sales, Personal Property. This requires two entries, one in the agency's fund and one in the deposit fund. Once the replacement is ordered, the agency must record a third and fourth entry to transfer the funds back to the agency fund. If no replacement is ordered in time, the new entries transfer the funds to the General Fund. So, using the same assumptions as above, if the agency collected the funds before the replacement was ordered, the initial entry would be:

in the agency's appropriated fund and the entry in F3845 would be:

Once the agency has earned the right to use the sale proceeds by purchasing replacement equipment, the transfer back would record in F3845:

The net effect of all four entries is the same as the one Purchase Precedes Sale entry except for offsetting balances in 5720 and 5730.

Reconciliation

Since 5700 is reduced by the sale proceeds, the balance of 5700 will not equal funded expenses (such as 6100) plus purchases (accounts 8802-8804) as it would normally in an appropriated fund. Total expenditures (49xx series) should still equal funded expenses plus purchases, and 5700 would equal expenditures net of reimbursements (in this case, account 4266). This is also true if the appropriation is supplemented by Economy Act reimbursements (generally 5200 in the proprietary accounts, 4251 and 4252 in the budgetary)

or offsetting collections (5740 proprietary or 4114 budgetary). However, in those cases, the supplement has an associated revenue source which facilitates the reconciliation of general ledger account balances, whereas 5720 represents disposal proceeds only if the funds are transferred in and out of fund F3845 (other-

New data on federal-private compensation gap rekindles debate

Recent data indicating that the average federal employee enjoys better pay and benefits than the typical private sector worker is misleading, according to federal employee groups and nonprofit organizations.

The data, released last week by the Bureau of Economic Analysis, does not break down compensation by profession or geographical area, critics noted.

"We've seen this movie before," said Max Stier, president and chief executive officer of the nonprofit Partnership for Public Service. "It makes no sense to compare across-the-board averages of public sector and private sector salaries. Would people be surprised that people who work in the high-tech sector make more than people who work in construction?"

According to the statistics, the federal government's 1.8 million civilian employees made an average of \$77,143 in 2007, while the standard private sector salary was \$48,035. With the value of benefits tacked on, average federal compensation rose to \$116,450, while typical private sector employees reaped \$57,615.

Chris Edwards, director of tax policy at the libertarian think tank the Cato Institute, wrote in a blog post that those numbers should prompt a salary freeze, and urged government to contract out some highly paid and highly skilled jobs like those of air traffic controllers. Edwards, who has made similar arguments in past years, said he recognized that the data did not provide a job-by-job comparison, but he said it was still important because it placed a value on federal benefits. Other figures, including those published by the Bureau of Labor Statistics, only look at salary, he said.

"It's the most comprehensive measure of compensation in [the] federal versus private [sectors]," Edwards said.

Colleen Kelley, president of the National Treasury Employees Union, said federal benefits actually had stayed fairly constant in value, and federal employees were not overcompensated compared to their private sector counterparts. "In the face of largely static benefits for federal employees, there is unfortunately ample evidence of significant private sector cutbacks in employee benefits -- health insurance and pensions, just to name two -- playing a substantial role in any such comparison," Kelley said.

Randy Erwin, legislative director for the National Federation of Federal Employees, said federal salaries were artificially inflated by the contracting out of many low-wage federal jobs.

"On the whole, federal workers perform work that is of a higher level and complexity than the average private sector worker," Erwin said. "The government jobs that remain are highly skilled and increasingly specialized, and they are properly classified at higher grade levels. Grades GS-11 to GS-13 are the most common."

Matt Biggs, legislative director for the International Federation of Professional and Technical Engineers, said he was frustrated that the Bureau of Economic Analysis continued to release the data.

"This is becoming a consistent, but misleading analysis by the Bureau of Economic Analysis, which unfortunately is fueling business-friendly special interest groups like Cato to advocate for costly federal contracting schemes," he said.


