Have you completed your 80 CPE's yet? Don't forget that you need to finish your 80 biennial CPE's by year's end if you earned your CGFM in an odd number year, such as 2015, '13, '11, '09 '07, and so on. The Seattle AGA CGFM Chair undertook the brutal endeavor of a 6-day live broadcast webinar course on the three CGFM study guides. Joking. It was not brutal and it was split up as 3 days of training each. One grouping was held in October and the second grouping just ended on November 29. The Salt Lake City AGA Chapter hired two trainers to instruct live at their location and broadcast the training to remote sites in Boise, Idaho, and Seattle, Washington. The courses count as 48 credit hours for those currently accredited with a CGFM if it has been at least two years since you passed the exam(s). The cost was only \$550 for AGA members and included the three study binders. The broadcast worked very well overall and the Seattle Chapter hopes to offer the same or similar training in the future. The **Platinum Chapter Designation** will be presented to any chapter that attains between 19,501 and 25,000 credits for the year. The chapter president's plaque will include recognition that the chapter has achieved Platinum status.
