Did you know that you can braid funds from Department of Education, Department of Transportation and a local focus on pre-school child care? Or the Department of Agriculture, Health and Human Services and a school district nutrition programs?

Federal grants account for \$600 billion, annually, in federal spending. This spending supports 2,275 federal programs across 68 federal agencies. Services funded with these dollars are frequently delivered by states, counties, municipal governments and their grantees. This webinar will examine a recent AGA Guide to help you leverage different funding sources to optimize programs for better performance and outcomes.

AGA offers a free online guide, *Blended and Braided Funding: A Guide for Policy Makers and Practitioners*, which outlines opportunities and challenges for promoting cross-program coordination to provide the best services in the most efficient and effective manner. The *Guide*, developed by AGA's Intergovernmental Partnership, provides several examples of innovative funding strategies that can be used when programs - whether federal, state or local - serve the same or similar clients or purposes (e.g., homeless students and families; clean water initiatives; etc.).
