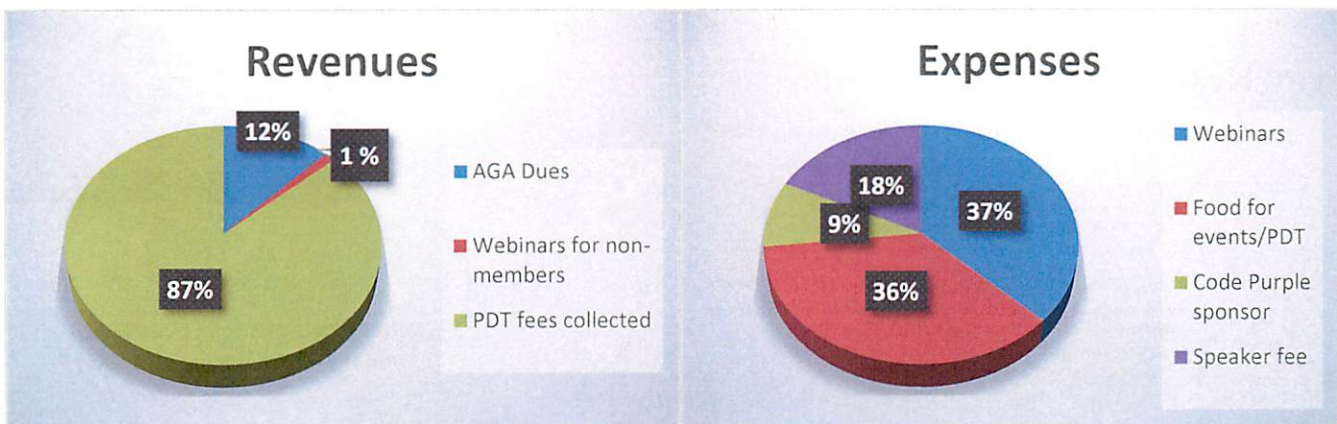

In 2018-2019 we had the highest Membership growth out of about 100 AGA chapters nationwide at 19%. The previous year we were down to about 34 members at our lowest point. 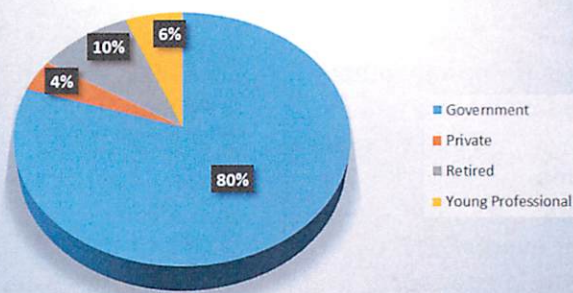

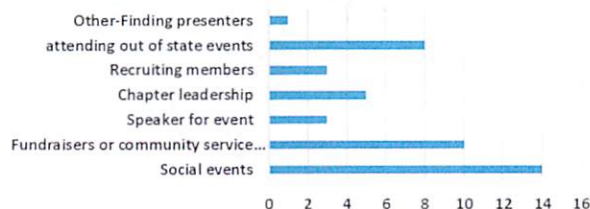
What subjects are you interested in learning about?
