MAINTAINING DESIGNATION

Annual Renewal

The 2014 CGFM renewal season is almost here! Annual CGFM renewal payment is due by March 31. Starting in January, CGFMs can renew their designation online. Need to update your address? <u>Log into your AGA account</u> and update your contact information today!

CPE Cycle

If you earned your CGFM designation in an odd year (not including 2013), your two-year CPE cycle ends this Dec. 31. Please be sure you have earned your 80 CPE hours in government financial management topics or related technical subjects. If you are short on hours, you can utilize a grace period of Jan. 1-Mar. 31, 2014. Please see CGFM CPE requirements for more information.

CPE Documentation

When renewing, CGFMs do not need to submit supporting documentation of CPE hours earned. Payment, itself, serves as the CGFM's affirmation of compliance with CPE requirements. However, active CGFMs are required to maintain supporting documentation of CPE hours earned, for a minimum of three years, and provide it to AGA upon request. This documentation may be requested by AGA as part of an annual audit of a random sample of CGFMs. Please refer to CGFM CPE requirements for more information on maintaining your CPE documentation.




