# President's Message

Welcome to this month's DC Chapter newsletter. A special thanks to Mr. Mark Easton, the Deputy Chief Financial Officer of the Department of Defense for his insightful presentation on "Financial Improvement and Audit Readiness and Where it Fits in the DoD Financial Management Strategy" at our April educational luncheon. Mr. Easton's presentation was informative as he moves the Department of Defense toward auditability. He and others face a major task given the size and complexity of DoD in meeting CFO Act requirements. The Financial Community should welcome the opportunity to assist DoD in its quest.

I also would like to welcome Ms. Wendy Payne as the featured guest speaker at our upcoming May luncheon. Ms. Wendy M. Payne is the Executive Director of the Federal Accounting Standards Advisory Board (FASAB). As Executive Director, Ms. Payne manages the research staff supporting Board deliberations. She is a Certified Public Accountant and a Certified Government Financial Manager. Ms. Payne's topic for our May luncheon is, "What's up with the Reporting model?"

It is of special note that with the passage of the CFO Act of 1990, the Secretary of the Treasury, the Director of the Office of Management and Budget OMB, and the Comptroller General established the FASAB to develop the "applicable accounting principles" for the newly-required financial statements. The FASAB Board's Steering Committee, comprised of the Chairperson and the Board members from Treasury, OMB, and GAO, is responsible for administrative matters. Both Board and Steering Committee meetings are open to the public, with notice of meeting times and locations published in the Federal Register and at [www.fasab.gov](http://www.fasab.gov). Nearly ten years later in 1999, an AICPA task force, after reviewing the Board's policies and procedures to determine conformance with AICPA's criteria, promulgated FASAB to establish GAAP for the federal entities within the United States. Ms. Payne has been instrumental to the federal community in understanding and applying applicable standards. Without her and her staff, agencies could not have made the advancements to auditability.

The May 15th-16th AGA DC /GWSCPA 2012 educational training sessions, "Tackling Financial Management Challenges in Extraordinary Times" will feature representatives from the FASAB, OMB and Treasury who have the primary responsibility for federal accounting standards. So sign up with colleagues and friends. More information can be found in this month's newsletter or on the DC Chapter's website.

Lastly, often there is a tendency to look for low-hanging fruit as an agency works to implement audit-related recommendations. I suggest taking the approach based on risk. In other words, determine, using a risk matrix, which recommendation will be addressed first. Your goal is to minimize risk to the organization and/or program. In this environment of scarce resources, it is important to focus on the big rocks in the jar first, then the sand surrounding it.

### Eileen W. Parlow

Ms. Parlow is an Assistant Director with the FASAB. She came to FASAB in February 2004 from the Office of the Under Secretary of Defense (Comptroller), where she had the lead responsibility for implementing the U.S. Government Standard General Ledger, credit reform accounting, and the OMB’s Business Rules for Intragovernmental Transactions. She has worked for over fifteen years resolving Federal government-wide accounting and reporting policy issues at the Department of Defense, the U.S. Department of Education, and the FASAB, often serving on the U.S. Standard General Ledger Board and numerous other government-wide working groups. At the U.S. Department of Education, she was responsible for budgetary reporting and audited financial statements for the Direct Student Loan Program. Prior to her Federal career, Ms. Parlow’s experience included non-profit accounting, private sector financial statements, and four years as the Comptroller for the U.S. operations of the London Times.

In addition to a Summa Cum Laude Bachelor of Science degree in Accounting from Southeastern University, Ms. Parlow holds a Bachelor of Arts degree with departmental honors in Psychology from St. Joseph’s College in Brooklyn, NY, and a Master’s degree in Theological Studies from Harvard University. Ms. Parlow received an Elijah Watt Sells Certificate With High Distinction from the AICPA for her performance on the November 1993 Unified Certified Public Accountant Examination, and she was recognized by the Virginia Society of Certified Public Accountants for achieving the highest score in Virginia. She is a Certified Public Accountant licensed in the Commonwealth of Virginia and a Certified Government Financial Manager.

Mr. Dalkin is a Director in the Financial Management and Assurance Team with the U.S. Government Accountability Office (GAO). He also serves as a member of the AICPA’s Auditing Standards Board and as an observer on the COSO Advisory Board.


Mr. Dalkin has responsibility for directing GAO’s work to develop and maintain government auditing standards (the Yellow Book); internal control standards for the federal government (the Green Book); and GAO’s work with the accounting and auditing profession. He is also responsible for the audits of the Securities Exchange Commission and the Statements of Social Insurance included in the consolidated financial report of the United States. Prior to joining the GAO, Mr. Dalkin served at a global firm and audited a wide range of organizations ranging from commercial health care entities to governmental agencies.

Mr. Dalkin is a frequent speaker at national auditing conferences for AICPA and other professional organizations. He has also authored articles for publications including the Journal of Accountancy. He has contributed to the profession through his involvement with the AICPA Task Force on Restricted Use Reports and chairs the International Disclosures Task Force. Mr. Dalkin serves as an adjunct accounting faculty at Georgetown University. Mr. Dalkin has a Master’s Degree in Business Administration from the George Washington University and a Bachelor of Science in Accounting from the University of Virginia.

## Community Service

April is Autism Awareness Month. The DC Autism Parents (DCAP) was chosen by the Washington DC Chapter of the Association of Government Accountants (AGA) as our community service project for the month of April. The mission of DCAP is to improve the lives of all affected by autism in the Washington, DC Metropolitan area through advocacy, education, support, services, and research in order to promote community inclusion and awareness. The organization was created by parents of children with autism for parents of children with autism.

Autism Spectrum Disorder (ASD) is a complex developmental disability that typically appears during the first three years of life and is the result of a neurological disorder that affects the normal functioning of the brain, impacting development in the areas of social interaction and communication skills. Individuals with ASD live a normal lifespan. There is no cure for ASD but it is treatable. Early diagnoses and appropriate intervention are vital to the future development of the child.

Ms. Yetta I. Myrick, the mother of an eight-year-old son with autism, and Founder, President and Executive Director of DC Autism Parents (DCAP) was on hand at the April luncheon to give information on autism and how the organization can assist the community. Ms. Myrick oversees the daily operations of DC Autism Parents (DCAP) and has created and overseen programs specifically created for children with autism and their families, such as the DC Autism Buddies Program, Support Groups Meetings, an Autism Resource Guide, and Lending Library.

A special thanks to the DC Chapter for your generosity. DC chapter members donated \$191.00 to this worthwhile cause at our April luncheon.

Our May Community Service Event will be collecting used eye glasses for the Lion's Club and used cell phones for HopeLine, sponsored by Verizon Wireless Communications. Verizon Wireless' HopeLine program turns unused wireless phones into support for victims of domestic violence. Verizon Wireless collects no-longer-used wireless phones, batteries and accessories in any condition from any wireless service provider.







# Inside the Black Box

## Automating Allowance for Doubtful Accounts

### Introduction

The process to assess and revise the allowance for doubtful accounts is cumbersome and memory-intensive. Agencies must take care when automating this process to maintain functional integrity.

### Allowance for Loss Accounting Entries

When an agency recognizes revenue or a reduction to expenses associated with a receivable, the matching principle requires that the agency also recognize a potential expense (contra-revenue for nonexchange revenues) for any loss due to the debtor's lack of creditworthiness. The account which offsets accounts receivable, to reduce it to its anticipated value, is 131900 Allowance for Loss on Accounts Receivable (similar accounts exist for allowance on interest, loans, fees, and taxes receivable). The Standard General Ledger (SGL) transactions associated with this account are:

Allow for bad debts:	dr.	672000 Bad Debt Expense
D404	cr.	131900 Allowance for Loss on Accounts Receivable

Write off bad debts:	dr.	131900 Allowance for Loss on Accounts Receivable
D408	cr.	131000 Accounts Receivable

If no allowance is accrued, then bad debts are written off using the direct write-off method:

Direct write-off:	dr.	672000 Bad Debt Expense
D404 + D408	cr.	131000 Accounts Receivable

### Allowance for Loss Process

The allowance recognizes bad debt expenses, which must be matched against current revenues. An entity could record this simply as a percent of the revenues, or it can assess a different percentage based on the age of the debt or financial strength of the debtor. Traditionally, this accrual was made at the end of the year, so the bad debt expense only showed up in the annual statements and the allowance for doubtful accounts fell during the year as it absorbed write-offs, then jumped at the end of the year when the new assessment was made. The allowance would be adjusted if, at any time, either (1) the allowance exceeded the outstanding accounts receivable, or (2) the allowance went negative/debit.

## Inside the Black Box (cont'd)

If an entity has a lot of small receivables, it can accurately estimate the allowance based on revenue. If the receivables are diverse, then it is necessary to group them into cohorts and assess bad debts expense against each cohort. Normally, the assessment has a memory. If an agency extends credit to a cohort for \$100,000 and estimates 2% is uncollectible, then the initial allowance is \$2,000. As the cohort ages, some debts are defaulted while most are collected. As debtors default, the agency writes off the bad debt by reducing the allowance. If, in our example, the debt is for a short term, after one year we may have collected \$97,500 and written off \$1,800 with \$700 outstanding. Since the allowance is now \$200 = \$2,000 initial assessment - \$1,800 write offs, the 2% estimate has now evolved into a 29% estimate. If the agency collects the remaining \$700, then it should back out the allowance accrual for \$200, while if the agency writes off the remaining \$700, then it should first increase the allowance accrual by an additional \$500.

<i>Event</i>	<i>131000 Debt</i>	<i>131900 Allowance</i>	<i>Implicit Rate</i>
<i>start</i>	<i>100,000</i>	<i>2,000</i>	<i>2%</i>
<i>collections</i>	<i>-97,500 = 2,500</i>	<i>2,000</i>	<i>80%</i>
<i>write offs</i>	<i>-1,800 = 700</i>	<i>-1,800 = 200</i>	<i>29%</i>

### Automating the Process

An ideal attribute of a process to be automated is that it should be memoryless. In other words, the tool should not have to analyze a long history, but look solely at the current status. So an automated tool that assesses the allowance for doubtful accounts would ideally be set up to back out the prior assessment, look at outstanding receivables, assess the allowance as a percent of each age group or cohort, and book the new amount. An automated tool could be run monthly to keep the allowance current, so we would avoid the problems of having the allowance go negative or exceed the outstanding receivable. However, if the tool only looks at open receivables, it will ignore those written off during the year, which will require the agency to book write-offs directly against Bad Debt Expense. In our example above, when we start the year with \$100,000 and 2% default rate, the tool will post \$2,000 to bad debts and the allowance. At year-end when we have \$700 outstanding and, assuming a default rate of 30% for year-old debt, the process will back out the \$2,000 assessment and instead record bad debts and allowance of \$210. However, we already wrote off \$1,800. So the write off will have to increase Bad Debt Expense just as if we were using the direct write-off method. In that way, the bad debt expense will be \$1800 write-off + \$210 accrual = \$2010, while the outstanding receivable is \$700 and the allowance is \$210.

## Inside the Black Box (cont'd)

The percentage that is applied to the outstanding receivables has to take into account not only the age of the debt (the longer a debt is overdue, the more likely it will never be collected), but also how aggressively the agency writes off overdue debt. Say we are 6 months into the year and we have \$10,000 open receivables and the expected default rate is 10%. If we run the assessment tool, it will accrue \$1,000 bad debt. Suppose we write off \$500, and that this has no effect on our assessment of the collectability of the remaining \$9,500. If we run the assessment tool with the original default rate, bad debts expense will be \$500 for the write-off plus \$950 estimate for a total of \$1450. Since writing off the debt should not increase bad debts expense, the default rate should be lowered to close to 5%.

### Conclusion

Calculating the Allowance for Doubtful Accounts and Bad Debt Expense is not simply a matter of applying a standard percentage against outstanding debt or against revenue. Collecting debt reduces the outstanding receivable and increases the riskiness of the remaining receivables, whereas writing off debt reduces the outstanding receivable and decreases the risk that remaining receivables will default. Also, Bad Debt Expense is composed of both the allowance accrual and actual write-offs.
