# Call for Nominations—National Governing Board

AGA's new structure takes effect July 1, 2019. Our Leadership Development Committee (LDC) is currently identifying candidates for these positions on the first National Governing Board:

Six (6) Directors (for Chapters)

#### **CHAPTER EXECUTIVE COMMITTEE (CEC)—MINUTES FOR JANUARY 11, 2019**

The meeting was called to order at 11:44am.

# President:

- Internal discussion about the use of the CGFM designation. The outcome was favorable to the accused; however, CEC should note that CEC business should be kept in-house - approach the accused first before bringing it to outside parties.

- Corrine was acknowledged for receiving the Excellence in Government Leadership award for 2019 - will be recognized in February at the AGA training. Corrine requested reimbursement for hotel for one night and this discussion was tabled. (**Winston**, can you please add this to the

- Discussion about the cost of travel. Betty has received inquiries from members about the high cost. CEC needs to create a policy that travel requests be submitted to the employer first, then the chapter - discussion was that the CEC already expected that. Further discussion about travel to the PDT. Concerns about sending the same people multiple times. Response from some was that we are paying for the position, not the person. **Saa'dia** (RVP) will put together a proposal for her and Winston to attend the PDT next year with details on costs, as both have voting responsibilities and are expected to attend. We also will have one extra hotel scholarship to discuss.

- With new governance structure, the RVP position has been removed after FY19. National created a new NCC position and recommended that Randy Sherrod fill the position since he had been previously elected as RVP-elect. The current RVP (Saa'dia) discussed this nomination with Randy and he was happy to accept. Saa'dia motioned to place Randy in this position,
