My friends and colleagues,

As I pen this final President's message, I pause to reflect on the accomplishments the chapter has had over the past year, the measurement of goals achieved compared to goals established. At the beginning of my tenure as Chapter President, three goals were established for the 2018-2019 program year; 1) Continue to provide quality seminars to the membership at a reasonable price while keeping the seminars relevant to today's environment, 2) Promote CGFM more strongly and encourage young professionals to see the value of the AGA, 3) Develop new and different ways to promote AGA and increase awareness and membership.

I am happy to report that the chapter has met two of its three primary goals for this program year. As of the end of June 2019 our membership is strong at 304 active members, of which 3 are students. 
Accountability

- Read everything about CGFM certification on the AGA website
- Start your preparation with the examination content outlines and pay special attention to the acronyms and sample questions
- Review additional references in areas with which you are less familiar
- Make flashcards for local, state, and federal terms
- Use reputable resources, such as AGA materials, information provided by a government agency or college textbooks (beware of poor quality materials that are sometimes sold online)
