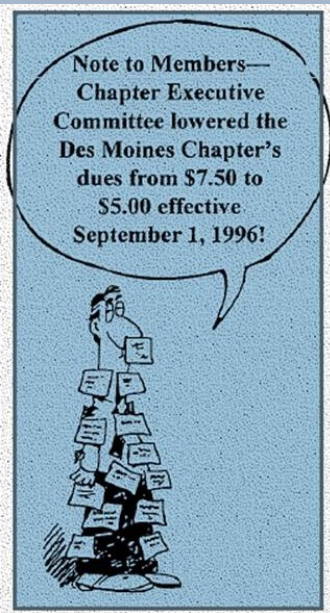

**What is CGFM?** The AGA Certified Government Financial Manager®(CGFM®) credential allows professionals to expand their career options by demonstrating they have the unique skills and special knowledge required of today's government financial managers at the local, state, and federal levels.

**What makes CGFM Unique?** The CGFM® credentialing program focuses on the various aspects of government financial management at all levels of government. In preparing for the CGFM exam candidates gain a better understanding of the "big picture" of government and increase their knowledge in the various aspects of government financial management.

**CGFM Initial Requirements?** To receive CGFM certification, candidates must read and agree to abide by AGA's Code of Ethics, have a bachelor's degree from an accredited college or university, pass three comprehensive CGFM examinations, and complete at least two years of professional-level experience in government financial management.

**Congratulations to Kim Ashmore for passing the 3rd and final part of the CGFM exam in April!!**

### CGFM's, do you know what your CGFM CPE requirements are?

One of the requirements to maintain your CGFM certification in active status is to complete at least 80 hours of continuing professional education (CPE) every two years in government financial management topics or related technical subjects. The two-year cycles begins on the January 1 following the date you were awarded your CGFM and continues on an odd- or even-year basis thereafter (i.e. if you were awarded your CGFM in an odd year, your two-year cycle ends in an odd year; CGFM awarded in an even year, your two-year cycle ends in an even year).

You do not need to submit supporting documentation of CPE hours at the time of renewal but you must maintain your supporting documentation for a minimum of three years and provide it to AGA upon request.

CGFM CPE requirements, while similar in many respects to those of the AICPA, IIA, or state boards of accountancy, are not identical. Examples of training topics that may qualify as CPE for state licensing bodies or other professional organizations, but would not generally qualify as CPE for the CGFM certification, include certain training in taxation personal financial planning and investment, taxation strategies, estate planning, retirement planning, practice management, etc.

CPE that would satisfy the CGFM Program Requirement must be in Government Financial Management topics or related technical subjects applicable to Government Financial Management. A list of Topics and Subjects that generally satisfy these requirements can be found in [SECTION 12](#) on the [AGA CGFM CPE Requirements](#) webpage.

## Historian's Corner, Janice Evans:

Do you remember when AGA did not have a Certification Program? A study on this started in 1985. The following is from the February 1985 newsletter.

News from National - CERTIFICATION STUDY IS UNDER WAY - An AGA taskforce is studying the feasibility of a certification program in governmental accounting. A survey will be sent to a sample of AGA members for their comments on such a program.

It took awhile for the certification program to be fully implemented. The following about the Certified Government Financial Manager (CGFM) designation was from the February 1996 Newsletter.

The grandfathering period for the CGFM program ends June 30, 1996 - LESS THAN SIX MONTHS AWAY.

The grandfathering period allowed eligible applicants to become a CGFM without taking the examinations. After the grandfathering period ended, CGFM certification is earned by reading the AGA Code of Ethics, applying for the CGFM program, submitting required degree documentation, receiving an eligibility letter, submitting a work verification form, and passing three CGFM examinations.

The Des Moines Chapter has over 35 members with CGFM designations, with several others currently working on the certification. Consider joining this group of Certified Government Financial Managers.

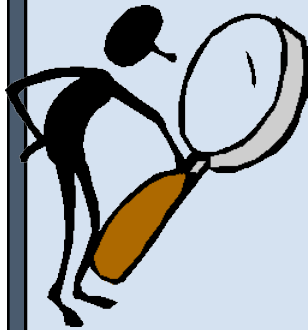

### GET WITH THE PROGRAM/FITNESS THAT IS

For those few AGA members who have not "gotten with a physical fitness program" as yet--waiting for nice weather, getting over peak job demands; or just getting over being lazy--now's the time...

Weather is getting super nice to be outside and with just a few precautions such as: wearing a cap to keep direct sun rays off face if severe, put on sun lotion when needed, especially on nose and face; try getting outside at other than hottest time of day (usually around noon) and drink plenty of liquids to avoid dehydration--no reason why you shouldn't "get with the program."

To repeat previous suggestions, to condition yourself aerobically, strengthen heart and lungs, you must exercise aerobically at least 20 minutes continually at a time no less than 4 times per week. Anything involving moving your legs will work: i.e., biking, jogging, walking, swimming. All these are much more beneficial if done out of doors which will provide not only physical fitness but also mental relaxation and enhance stress management.

Remember, it's always too hot or too cold or too wet or too dry to get outside for some exercise and fresh air--if you want it to be. Forget that type excuse and do yourself a favor and get on a regular schedule of going outside, at whatever time of day works best for you and do something to get your heartbeat going--easing into it a little at a time.
