





Twelve Memorable Speakers

**Abraham Brillhoff, educator and author of the book
“Unaccountable Accounting”**

Mr. Brillhoff practiced accounting and taught the subject as a professor at Baruch College in Manhattan. He became famous for the articles he wrote for Barron's and his books, which enumerate many examples where managers misapplied accounting rules and auditors did nothing about them. He was revered by investors and vilified but also respected by companies and their accounting firms. Dr. Brillhoff spoke in 1978 and again in 1985, when he spoke on "Accounting and Society: A Broken Covenant."



**Peter Drucker,
renowned management consultant, educator and author**


His many books were filled with lessons on how organizations can bring out the best in people, and how workers can find a sense of community and dignity in a modern society organized around large institutions. He spoke in 1974 on "Management by Objective."



Congressman Jack Brooks, D-TX

Congressman for 42 years. His Inspector General Act established independent Offices of Inspector General in major agencies to prevent fraud and waste.


Other Brooks bills reduced federal paperwork, provided a uniform system of federal procurement, eliminated overlapping audit requirements and established the Department of Education. He spoke in 1987 on “The Political Side of the Balance Sheet.”



G. Edward DeSeve

Controller and Deputy Director of OMB under President Clinton; Chief Financial Officer of HUD; Special Adviser to President Barack Obama for the American Recovery and Reinvestment Act. He spoke in in January 1995 on his early impressions and challenges at his new position as OMB Controller, and again in October 2009 on “Risks within the Recovery Act.”

As Deputy Assistant Secretary for Accounting Policy at Treasury, Mark Reger spoke in 2011 and 2013 on the consolidated financial report of the U.S. Government. Currently the Deputy Controller at OMB, Mark is the FASAB Board member representing OMB; he also represented Treasury on FASAB from 2010 -2014. Mark also serves as a Senior Vice President at AGA National.



Gene Dodaro, U.S. Comptroller General

Gene Dodaro spoke at the September 2013 luncheon about financial, management and fiscal challenges for governments at all levels by the combination of slow economic growth and constrained resources, and what GAO's work suggested for moving forward.



Wendy Payne , FASAB Executive Director

FASAB staff member since 1991 and FASAB Executive Director from 1996 to the present; also a past DC Chapter President. Wendy is a regular speaker at Chapter luncheons and at the Chapter's annual spring training event, providing members with news and insights on FASAB's recent issuances and current projects.

Factoid: When then-Acting Comptroller General Gene Dodaro was scheduled to speak at the chapter's April 1998 luncheon, he was called to the hill a day early to testify on GAO's audit of the FY 1997 Consolidated Financial Statements of the U.S. Government. Wendy rose to the occasion on very short notice, and gave a presentation on the FY 1997 CFS and its audit results from GAO, as well as an update on FASAB's activities.
