The 2018-2019 program year ended with a record breaking 7 new Certified Government Financial Managers (CGFM)! The educational program for the chapter included 16 hours of CPE of CGFM exam review. The Chapter offered CGFM review classes for the 4th year.


- Online Payment Options for Government;
