Education

- Each fall, the Central Ohio AGA presents the Professional Development
 Training (PDT) which offers an excellent slate of speakers and a wide
 range of break-out sessions. Last year, our annual PDT provided 16 CPE
 hours to over 200 attendees. Due to the COVID-19 pandemic, we will be
 hosting our first-ever virtual PDT event in the 2021 Program Year. While
 we foresee some challenges related to the change in format, we look
 forward to providing our members with the same quality content they
 have come to expect.
- The Chapter offers CPE sessions throughout the year. Each session ranges from one to eight hours and are often free to members registering in advance. During the last fiscal year, we provided a total of 32 CPE hours.

Community Service

- In June of 2020, COAGA donated \$300 each to USO Operation Phone Home, Mid-Ohio Foodbank, Faith Mission, and the Homeless Families Foundation.
- In January, volunteers of both members and guests worked with the House Chef at the Ronald McDonald House to prepare and serve lunch for the families of hospitalized children.

Developing Leaders

 The Chapter has an ongoing commitment to providing diverse leadership opportunities to our members. From one-time roles at our Professional Development Training to a multi-year position on the Chapter Executive Committee, we believe that our members' successes and experiences in these endeavors better prepare them to seek out additional leadership opportunities in their professional lives.

Social Events

 Throughout the year the Chapter holds a number of social events for members and their families. Some of the events held in the past year included a golf scramble at New Albany Links and a happy hour after the annual PDT. Due to the COVID-19 pandemic, our social events were limited but we hope to have more in the upcoming chapter year!






Member Makeup
