Education

- Each fall, the AGA – Central Ohio Chapter presents the annual PDT Professional Development Training (PDT) which offers an excellent slate of speakers and a wide range of break-out sessions. Last year, our chapter provided 16 CPE hours to 165 registered attendees. We had 29 different presenters with a total 23 general and break-out sessions. The PDT featured nationally known speakers and current topics designed to educate and inform on both technical and social skills.
- The Chapter offers CPE sessions throughout the year. Each session ranges from one to eight hours and are often free to members registering in advance.

National Recognition

- During this year's National AGA PDT, AGA - Central Ohio Chapter was once again awarded the Platinum Achievements in Excellence (ACE) award.
- In April of 2024, AGA – Central Ohio Chapter Executive Committee members Tiffany Ridenbaugh and Erin Hill attended the LEAD (AGA's chapter and national leadership training event). This event provided insight on member incentives, resources that can be utilized from National AGA, and general best practices for our Chapter.

Giving Back to the Community

- In 2024, the AGA - Central Ohio Chapter awarded five \$1,000 scholarships to high school and college students whose parents are involved in our local chapter.
- In 2024 the AGA - Central Ohio Chapter made donations to the Mid-Ohio Food Bank, Columbus Relief, and Lutheran Social Services.

Social Events

- Throughout the year, our Chapter holds a number of social events for members and their families. In 2024 we hosted a Golf Outing at the New Albany Links.
- We had one of our largest turn-outs at the post-PDT Happy Hour! Thank you to all that attended. We strive to provide multiple social networking events such as this.

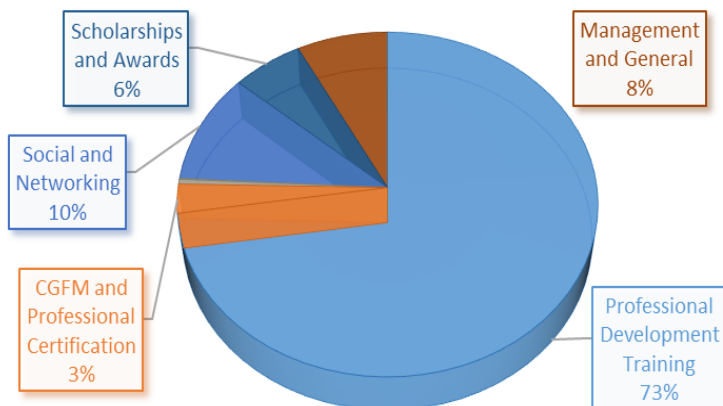

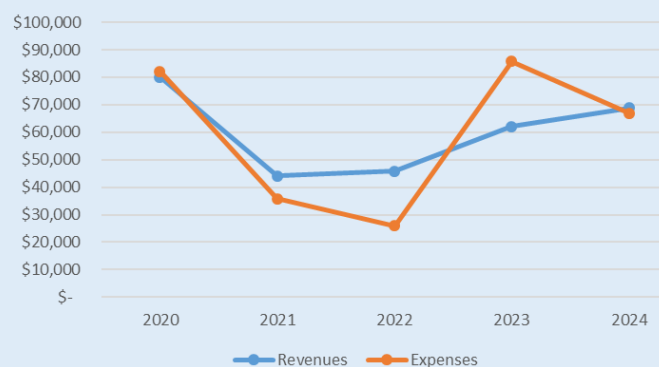
Our chapter had a net assets of \$46,018 in 2023. As of June 30, 2024 net assets for the AGA - Central Ohio Chapter were \$47,930. Expenditures are expected to remain similar as we intend to utilize the same resources for our annual PDT. With additional revenues, we hope to provide more networking events for our members through social and community service events.
